Mayor Pro Tem Todd Kinsey – just want to thank my colleagues and staff for helping work with me as my family as I try to figure out what is causing my heart issues. Every time I stand up my blood pressure shoots up through the roof and I feel like I'm going to pass out. We've got one more test they want to do, but it looks like I may be going in for some valve replacement. We'll know soon. Again, thank you all for accommodating us.

Hank Dugie – Thank you everyone, for being here tonight and for tuning in from home. Over the weekend we had a Council Strategic Planning Retreat. It was a wonderful retreat and beautiful location, far, far away, over in the Blue Building on Park Avenue. We, as we have the last few years I think, had a very valuable time together, kind of discussing what we want to do in the future. We do have some lessons learned. I think overall the theme of the event was to focus and hunker-down and to complete projects. That's kind of our theme going into this new year, focus on taking care of transportation and drainage projects that we already have planned out, execute them and deliver the services that citizens want.

Larry Millican – Welcome everybody, for coming and tuning in. I was with the Mayor over the weekend. We spent time in San Antonio yesterday and today, at the Transportation Forum put on by TxDOT. It was very informative, it was good. I enjoyed it as much as the last time. One, took a lot of things away, but one thing that I brought back, everybody at the dais got two articles. One was a wristband that says #End the Streak and we also had a little holder for cards on the back of your cell phone. Those were on the table this morning and I picked up one for everybody. What "End the Streak" is, is November 7, 2000, that was the last day 19 years ago that in the state of Texas that there were no deaths on Texas roadways, but every day since then on Texas roadways we've had deaths, averaging 10 a day. 3,800 people a year.

Out of those deaths, the take-away from one of the sessions was the fact that 90 per cent of those deaths every day were because of operator error in some form or fashion. They were all crashes that could have been prevented. The number one cause was distracted driving, on the cell phones, texting, but distraction one form or the other, include distraction eating, but distraction driving was the biggest. Along with that in deaths is going to be seat belts and speed and certainly, under the influence. But when you start thinking about 10 people a day, Texans, dying, and you think about 19 years since we've had a deathless day in the state of Texas on Texas roads, it's kind of sobering, it makes you stop and think. I thought it'd be a good idea to bring them back for everybody and in future meetings I'll be bringing back some more stuff. We have a Transportation Commissioner, Laura Ryan, she's a Houstonian. She comes to H-GAC meetings a tremendous amount and she is our voice up there on the Commission and she is the one who is pushing this program. She's the one who's very passionate about it and I think it would be good for all of us to get behind the program and start working towards the next day with no deaths.

Greg Gripon – Good evening, everyone. I just want to add one thing to Hank's talk about the retreat this weekend. I want to thank staff for coming out on a Saturday and taking their time to come spend with us and make the time to do that. It was really important, so thank you. And Peggy, thank you for coming Saturday also, and Dave. We'd love to have more citizens come and enjoy our Saturday at the retreat next year. Excellent. This Friday is the 14th, Valentine's Day and it's a time to prune your roses. Another really important thing to do, your sweetheart, tell her you love her. I just want to tell mine back there, LaTonnia, I love you.

Chad Tressler – Just to add another comment about the Strategic Planning Retreat, one theme of this year was we bit off a big chunk of work for our staff to organize, manage, and execute. The focus is going to be on execution, so we didn't spend a lot of time during this retreat doing a lot of long term, big picture dreaming, which we have done in the past and is important. But we're in a different phase right now. Part of execution, in my mind, is to have good policies and procedures in place. I'm a little biased, but I think right now we have a fantastic City Council in League City, and we might have the best City Manager in the country working for League City. You put those together and we have a great opportunity to execute. But they're not always going to be in place. There's no guarantee on the job what the next step will do unless you set up procedures to guide them that are going to manage that going forward. So that's something you're going to start seeing coming out of this Council. They're very focused on setting up those procedures for continued success. Keep your eye out for that.

Nick Long – I'll belabor, I guess, the same point everybody else is going to make about the retreat this weekend. I think what I took away from it, when I got back home my wife asked what did you do for six hours. I said unlike every other year when I was on Council, we didn't dream big, I think we need to spend time and focus. I think what the City Council can do, besides the policies and procedures, is resist the urge to go after special projects or pet projects or distract from the overall goal of completing what the voters said they wanted us to complete. So, I think we need to be mindful and need to challenge ourselves to let the staff focus on what the voters have already given them the money and an enormous amount of responsibility to do, and resist the urge as a Council to change those priorities mid-stream or to add smaller, distracting priorities on top on those. So, I think all in all, I'm very excited about where the City's going. I think that was general theme that I heard, but we've been entrusted with a huge amount of money and a huge amount of responsibility and I think we need to step out of the way and let the highly qualified staff knock out those projects.

#### Andy Mann – no comments.

Mayor Hallisey – I'll echo everybody else's comments on the Strategic Plan. I thought it went well. I am a little more focused on John (Baumgartner) because when I think about that Strategic Plan, I don't just think about the staff and their strategic plan. John has sort of drug us into the century with a lot of discussion of what we can do, how we are going to do it and that's a lot of what happened on Saturday. I like the idea of the best City Manager in the country. I'll settle for the best City Manager we ever had in this town. John leads us all. Many people who would like to look up here at the table, we have our role of John. Without John's leadership pointing us in the right direction, I think we'd have been floundering like many Councils in years past. So, John, we appreciate it. And in that vein, yesterday was John and Dee Dee's wedding anniversary. So, Happy Anniversary to you and Dee Dee. Eight years, over the seven-year itch, you made it. Justin, good job. This is your second year leading this fair, third. We're counting on you, I know you'll provide good leadership. I'll certainly be there, I want to encourage everybody else to be there. This Lions Club has been around this town for 66 years, has done more good probably than any other civic organization in town. It is a community fair, it's for all the people who live here as well as those who come to visit us. So, it's time for us to show off a little bit and get out there and support the Lions Club. Also want to call attention, this is African American History month. I'm reminded of that because those of you who know about Hobbs Road, I spoke several times about the Winfield-Hobbs family, who really came here in the 1870s and owned all the property from FM 518 to FM 517 along Hobbs Road. They were a significant part of League City's history, but somehow in the course of the 20th century they got forgotten. I told you before, Janice and I got to go to their family reunion last summer, and they are just full of stories about this community. They certainly helped as much as anybody at building the fiber of what League City is today. So, in honor of them and African American History month, congratulations to all them. Janice, I do love you, wherever you are. It is Valentine's Day. I know your birthday is three days later, so decide whether you want a present for Valentine's Day or your birthday.

#### 8. REPORTS FROM STAFF MEMBERS

John Baumgartner – I appreciate the kind comments from you and the Council. Obviously, it's a reflection of the entire staff, not just what I do and we appreciate the recognition and we'll continue to work hard. We'll continue to work for you and work to make League City the very best. A couple of quick announcements, just a reminder for the community, on January 31 we partnered with League City Regional Chamber to host our annual State of the City luncheon. Attendees got to hear directly from Mayor Hallisey and myself regarding the City's successes over the past year and priorities and projects for 2020. Everyone at the meeting received a copy of League City's Annual Report, which outlined some of the major milestones League City has made over the past year. We want all residents to be aware of these accomplishments, so we made this report available online at www.leaguecity.com. There's a video, about eight minutes, it tells a pretty good story on our year in review for 2019 and you can also pick up a printed copy of the annual report at City Hall. In addition to League Park, there are many other parks throughout the city that are undergoing additions and improvements starting in 2020. We want to ensure residents are aware of all the exciting things we have planned, so we're holding a Parks and Rec Saturday Social on February 29, Leap Saturday. Come out to Hometown Heroes at 8:30 for a free breakfast and a special update on what we have planned for city parks/recreational facilities, including the latest information on the west side Sportsplex. We hope to see you all on February 29 at Hometown Heroes Park. League City Police Department in cooperation with the National Shooting Sports Foundation and Project Child Safety is proving League City residents with gun locks, free of charge. The free gun locks can be picked up at the League City Police Department Mondays through Thursdays 8:00 to 5:00 and Fridays from 8:00 to noon. I think it's as long as the supply lasts – we have an endless supply. Gun locks are also available for pickup on weekends and after hours in the League City jail lobby. The Animal Shelter will be offering free micro-chipping for League City residents and \$5.00 for non-residents on Friday, Valentine's Day, February 14. Just bring your pet to the shelter any time between 10:00 a.m. and 4:00 p.m. to receive a free chip. Already have your pet chipped? Come in to check the chip with a chip scanner. Staff can provide you with your pet's micro number so you can verify the information is up to date. I'd like to give some updates on some CIP projects that we have going on. One milestone that we hit in January 2020, we invested \$3.5 million in the community. That was the highest month in the last three years. Continuing to grow, obviously our goal is to get the number up to \$5 or 6 million and up, but we're making progress.

Back in December, I think, the community reached out to us regarding the schedule for the Butler-Turner project and the closure that's coming shortly. One of the things in that community meeting we had was we had talked about delaying the start of the Butler-Turner project or delaying the closure until after Ervin is completed. We negotiated a change order with that contractor, our goal is to have Ervin opened in April of 2020. Once Ervin in open we'll start the closure for the Butler-Turner project to continue to improve the traffic circulation in and around League City Parkway and IH45. Calder Road, which is also in the same area, a different project, we awarded that bid back in December. That contractor had a notice to proceed issued today. We anticipate that project construction starting in earnest sometime in the next two to three weeks. It'll start with force main construction and waterline construction. One of the things with this phase of Calder Road, is that that contractor will keep that roadway open to two-way traffic for the duration of the project. It's a 500-day project, so they'll be out there a while as they move utilities, etc. Then on League Park, a couple of updates. That contractor has mobilized, the park has been fenced off entirely. I think what's important for me to remind the community is you'll see a lot of numbers on the construction of that project, it's about \$4 million total. About half of that is for League Park improvements. The other half, about \$1.3 million, is for drainage improvements. So, what does that mean? That's a drainage project that helps route some of the stormwater around the Historic District Instead of going down to Fourth and Kansas it will go through the west side of the park and then down Coryell Street, tying into the new stormwater boxes we have on Kansas. Another large portion of the project is the replacement of Coryell and the replacement of the waterlines along Corvell. So, it's a multi-faceted project, it's the second and third phase of the Downton Revitalization project. It's important. That project will take most of the year, so it involves the total closure of the park, including the boundless playground and the basketball courts. The other thing you'll hear a lot about is the turtles, and what happened to the turtles. For those of you who want to visit the turtles, they're now just a mile down the road in Heritage Park, which is actually a much more suitable and healthier environment for them. They've all been relocated, but there's one or two stragglers. Rusty Bolen has committed to me that he will gather those up and move them down the road also. A couple of projects got completed in January. One is Westwood drainage, which actually was one of the first drainage projects out of the bond program. That was out of the bond program that was completed about two months early and made some improvements in Westwood. The South Shore Harbour sinkhole drainage project near FH518 was completed in January and Smith Lane lift station. So, we have a number of projects that are going out to bid, most of those right now are lift stations. The drainage and roadway projects are shortly behind them. Appreciate the time to talk. Obviously, wish my wife a happy anniversary and a happy Valentine's Day. She's got a plan for me Friday, I'm not sure what it is, but I'm sure it'll be fun.
