Larry Millican – I attended the Clear Creek Consolidated Drainage District meeting today, out of that, the City of Friendswood gave a presentation that I was very impressed with, that I thought that I would share with the group tonight. They are well on the way with their bond projects, spending their allocated funds that they went out and the people approved, and I was impressed with that project, or the projects that are moving forward. But, a little bit of information on those is that, everybody kind of knows where Forest Bend is, it’s right there next to Clear Creek, and one of their projects is a \$3 million project for 70 acre-feet of detention right there in that Forest Bend area. That is well on the way and they expect it to be through somewhere in the two-year period they released that in June.

They've also got a project with some funds, and I don't know if you all know where Frenchman's Creek is, that's a condominium or townhome project that's on Clear Creek way up in Friendswood. And that project has been subject to flooding for years, and they're going to be buying dwellings. The City of Friendswood has got their grant funds going and they're going to be buying 20 of the dwellings there, and then Galveston County is going to use some of their grant funds to buy the rest of the dwellings out so that Frenchman's Creek will no longer be there in the future. They're also moving forward with another project they call Deerwood. It's going to be along the lines, upper area of Cowart's Creek back in, if everybody knows where the park was and their maintenance facility that flooded so bad, we had to help them out with some vehicles after the flood. But that whole area they're going to turn into a giant detention pond also up there. They've got a project that's going to be separated in different grants. Some of it's going to be an acquisition and then the other's going to be a grant to actually build the detention pond. And looking at the presentation from Friendswood, I was impressed with what they had, and an update on that Imperial Estates that I told everybody about, they're about halfway through, and Imperial Estates, they've now taken out about 79,766 loads of dirt out of that Imperial Estates and they're about halfway through. And when they get complete it's going to be over a thousand acre-feet of detention right on Clear Creek right there. That's the shelving project, yeah. That's that old subdivision there that used to flood. They turned it into a park and now they're just taking the dirt out. Good meeting this morning from the drainage district.

Mayor Hallisey – The only two things I have, these are always the unpopular things that, unfortunately, I have to do. Rosella Scott passed away this week. She was one of the longest serving school board members. She was at the Dickinson school board, but more importantly to us, she was the first African- American ever appointed to the Planning and Zoning Commission, or any board, in the City of League City in 1977. And she was a go-getter, and she was a great advocate for her folks and for schools in general and was a fixture around here for a lot of years. And then, as I mentioned to everybody last night, Darwin Gilmore passed away the other day. Mr. Gilmore was the chairman of our very first Charter Review Committee in 1961. He wrote the charter for this city originally. He was a charter member and organizer for the Clear Lake Area Chamber of Commerce back in 1958 or 1959. He worked for the school district. He was principal of several schools around here, has a school named for him on the west side of the town where Andy Mann lives. And he was just, he was a great patron of the library and sat on that Library Board along with Helen Hall for many years. And they were the powerhouses that really got that

library going. And they encouraged Johnny Arolfo to have the best damn library he could have in this town, and he did. Sorry to see both of them go, so our prayers are for both of them.

John Baumgartner – I’ve got three pages of announcements, I’ll abbreviate it, and just a couple of highlights. This week, Helen Hall Library is hosting a Grab and Go every day this week from noon to 2:00 p.m. Residents can stop by curbside to learn more about the various COVID-related resources available to them, ranging from food assistance and health services to financial aid and more. Attendees can also pick up a limited supply of free paper masks, five per person, inside an “I Love League City” reusable tote bag. The bag also contains several League City swag items, a COVID resource list and a 2020 Hurricane Guide. And then just kind of follow up on the budget conversation, there are two more work sessions, Monday August 17 and Tuesday August 18 at the Civic Center at 6:00 p.m. Members of the public can make a comment on the proposed budget using the online form at leaguecity.com/budgetcomment. The first reading of the budget, of the 2021 budget ordinance is August 25 with a public hearing also that night. The second and final reading is anticipated to be Tuesday, September 8 and I hope that we will have an approved budget. And then I’ve got a number of CIP highlights, but rather than talk about those tonight I just wanted to play a video on some of the progress we’ve made at League City park. As you know, the park has been under construction for most of the last five or six months. The goal is to have it done well in advance of Holiday in the Park, and so just kind of want to show you a quick video for that. (Video Played) I know everybody heard Marcos. The project is about a \$4 million project. About \$1 million of it was for drainage improvements, and those improvements not only help the park and help Coryell but they divert water from some of the other part of the Historic District, 4th and Kansas and 3rd and Kansas, in particular. And so, again it’s not just a park project, but it’s a drainage project tied in with road improvements on Coryell. And then I think we’ve got a couple of presentations from staff on the tax roll and tax rate and the Coronavirus Fund.
