Announcements concerning items of community interest. No action will be taken or discussed.

Mayor Pro Tem Todd Kinsey - Thank you sir. Just want to remind everybody that there is a Veteran's Day ceremony tomorrow at 10 a.m. at Hometown Heroes Park. I want to wish all my fellow veterans happy Veteran's Day. It is a much more happy event than Memorial Day, when we remember those who have fallen. Briefly, at the Library coming up the next couple of weeks, Teen's Anime will be this Monday on the 16th from 5:00 to 6:30 at the theater. They'll have popcorn. Join other book lovers on Monday night on the 16th from 7-8 for the League City Book Club. They've got some interesting books coming up, Churchill and some other interesting historic figures. And then finally, take part in the online reading rhythms program for children and families on the 18th at 9:30. Look for the link on the library catalog page and their Facebook Page. That's all I've got this evening, Mayor. Andy Mann - I usually don't say anything at this time, but I feel compelled to actually apologize for banging on the dais in support of Chad's comment about backroom deals, so I apologize. Thank you.

Hank Dugie - Thank you, Mr. Mayor. In our governance policy I'm sure it says something to the effect of if a council member breaks the dais, they have to pay for it. I'm sure Mr. Smith will send you an invoice. Anyway, let me give an update on I'd say a pretty productive meeting that the goals subcommittee had vesterday with the new City Auditor. I think it was a fruitful discussion. We're excited to have her onboard. It sounds like the January 12th meeting she will be bringing a couple of items to us. One being a proposed structure framework for the process and how she'll interact with the organization, which is something we've gravely lacking in past years. Also, an audit plan, something that all of us were pretty adamant about, but definitely Mr. Mann was adamant about, we want to see at least one of those audits on that plan be short enough where she can complete it by around the May timeframe so that we'll have something to review when the goal subcommittee meets then. Then we can give her annual goals for the following year. I'd say it was a productive meeting and I think we're heading on the right track. We're all happy that she condensed her 90 days goals down a little bit for us. That's basically it. It's an honor to serve with all of you and for everyone sitting here in the audience and watching from home, thank you for taking part in your government.

Larry Millican - Thank you, Mayor. Just real quick, I attended the Galveston County Consolidated Drainage District this morning, and just an update on the Imperial Estates is now they have 93,000 truckloads out of there. It's amazing. As long as the weather holds, they'll keep taking it out. That's all I have, Mayor, thanks.

Greg Gripon – no comments

Chad Tressler - Regarding Mr. Kinsey's comment, I realize that what I said may have been not taken the way it was intended. I wasn't implying that there was any sort of a backroom deal done. My response was a defense to the claim that we haven't given these people a hearing, haven't talked to them. I feel we do that here, and that was all I was saying. So, my apologies as well.

Nick Long - Thank you. One thing about the auditor, I would like to try to find a time at the first of the year to bring the auditor in and kind of help set that audit schedule. I was hoping after the initial 90 days or whatever they're going to boot up there, then they could bring it in in front of the whole council to help with that five-month runway. I think five months to finish one audit seems a little slow. I'd kind of like to have the new council set that schedule going forward and really push it. I believe in the past they've had to come to the Finance Committee to actually present those as well, so I'd like to bring the Finance

Committee in there and really have the Finance Committee put some input on those as well. I think maybe a workshop where we can openly discuss what's going to be on the audit plan would be worthwhile after the new year. One thing that everybody knows, is after these comments I'm going to request that we suspend the rules and bring up 13B just because there are a couple of citizens up here that are still waiting on 13B and that is the subcommittee for the beautification. And so I'm going to request that that is moved after this.

Mayor Hallisey - We had a workshop at 5:00 p.m. tonight. It'll be on tape if you want to see it. It revolves around an update on where the Ike Dike is, for those of you that follow that. That, hopefully, is our effort to put a stop to storm surges on major storms that come up the channel into the bay. It's an important project to League City, and it complements what both of our flood committees are doing on Dickinson Bayou and Clear Creek and the \$70 million that we're spending to improve neighborhood drainage, as well. When this started, we said that we were going to take a comprehensive view of drainage. We were going to look at all of the things that were in trouble. Most of our major hurricanes have been rain events, whether it was Harvey or Claudette, back in 79, which was 42 and 60-inches of rain. Storm surges didn't play into that, but the time is coming that we're going to get hit with the golden banana, which will be a major hurricane throwing a major bit of storm surge up into this bay, and we're going to have a major rain event right on top of it. Even though bridges have been elevated and ditches are getting dug, we're looking at it in every aspect. Mr. Dugie and Millican have led our charge on Dickinson and Clear Creek watersheds and done a good job. We're talking about a major county detention pond on Dickinson Bayou upstream to take some of that runoff. They're talking about the one out on 2351, that Harris County is putting together. And there will be others that come about. But we are in a flat coastal prairie and we are subject to rainfall flooding in a major way. We've seen it for a lot of years here in town, and we are also subject to major storm surges. Ike was a 17-foot surge and anybody that was out on the lake a month after the storm came in saw the massive yachts that were just thrown up into people's yards. That came from the storm surge coming up into the bay. I'm happy everybody's pumping up on all cylinders and things are getting done. They never happen fast enough. Good for that. I saw in the paper yesterday, I think I read this right, I'm not sure, it appears that we have a finalist to replace Dr. Smith at the school district. All of our hopes are that they found one just like Dr. Smith. A lot of us think he did a great job for the district. He certainly brought it back from some tough times. We owe him a debt of gratitude. I see everybody's having a roast and toast for him. I don't seem to get any invites to those but that's okay. By the first of the year we'll get to thank Dr. Smith for the great job he's done for this district. The schools are the No. 1 economic development tool that this city has. They come here because of it, and the quality of life. We all have been supporters of the schools in our own way over the years. Our kids went to them, learned to read, write and they've gone into life. Veteran's Day tomorrow, for all of you at the dais, I will see you there at 10:00 a.m. There are no excuses. Our veterans are worthy of your time, I don't care what you're

doing. I go every year and I start looking for people and I don't see them. Our veterans, you know, we're losing our World War II veterans. Every year the American Legion has a get together down there. All the World War II vets that are still with us come. Always great to visit with them, always great to hear their stories, and they tell better stories than I do so it's good to listen. There was a guy there last year who was a World War II vet that must have been 100 years old, and he was a fascinating guy. He just chatted at the table the whole time he was there. I was impressed by that, I love to hear those stories.

8. <u>REPORTS FROM STAFF MEMBERS</u>

John Baumgartner - Thank you, Mayor, Council Members. Just a couple of announcements. Just an update on CIP, I think I've been doing this regularly now. For FY2020, the total investment is \$59.3 million. It changes a little bit as the last invoices come in. We credit them back to the previous fiscal year. Hopefully, new year numbers come in the next meeting. A couple of projects completed in October were the Glen Cove water lines, the boundless playground, and then we completed the pavement management. We'll get a report, probably in a work session, to council, the street condition index, of all the streets in the community, to help us decide which streets are next for reconstruction or rehabilitation. Of course, League Park got completed. In November, force main upgrade for the Bay Colony Lift Station, a 16-inch water line from the South Shore Harbour Pump Station to 2094. Most of us didn't see that project because it went across the back of a school project. It was important to get that project complete before the FM 270 trail. There's a trail that goes over the top of it, so that all came together as it should. The League City Parkway at Hobbs Road right turn lane is completed. I think traffic is flowing a little smoother over there. Just one little bond project completed as of today. And then Veteran's Day, I know we've talked a little bit about it, I want to remind everybody that all city offices are closed, including the City Hall, City Hall Annex, Helen Hall Library, Municipal Courts, Hometown Heroes Recreation Center. Trash collection services will take place tomorrow as normal. The ceremony, as the mayor says, at 10 a.m., at Hometown Heroes. A complimentary lunch will be provided by AMOCO Federal Credit Union. Masks are required and temperature checks will be taken at the door. Seating will be limited to four per table, and commemorative t-shirts will be distributed to the guests on a first-come, first-serve basis. Then later this week, on Thursday, residents are invited to a public meeting November 12th to learn more about the preliminary master plan for the Bay Colony Park which is to be constructed on Irvin Street between Calder and Hobbs Road. The meeting will begin at 6:00 p.m. at the Johnnie Arolfo Civic Center, and the city's consultant will present the plan and look for feedback on the recent surveys and user discussion groups along with the preliminary drawings for Phase 1 work at the park. Phase 1 is slated to be five youth softball fields, a trail, restrooms, scoring facility, concessions stand, parking and maintenance building.

Then on Monday, November 16, residents are invited to a public meeting to discuss upcoming improvements to the Bayridge Park. This meeting will be held at Hometown Heroes at 6 p.m. Preliminary information will be shared by the city's consultant related to the new plan and residents will be able to provide their feedback and comments at that meeting. So, a meeting Thursday on the Bay Colony Park, 6:00 p.m. at the Civic Center, and then Monday, the 16th, at Hometown Heroes for the Bayridge Park. Over the last two weeks, two public meetings have been held virtually to present findings for the first two phases of the Lower Clear Creek and Dickinson Bayou Watershed Study. Residents who were unable to attend can review the presentations and watch the video recordings on the city's website at LeagueCity.com. The website also provides an online comment form for residents to provide their input and comments. Lastly, it's beginning to look a lot like Christmas around City Hall. Our Parks Department has begun decorating the city light poles with ribbon wreaths and holiday banners. Next week they'll be partnering up with League City Garden Club to decorate the new tree. Speaking of League Park, on Saturday, November 28, we'll be hosting the city's annual tree lighting inside the park rather than in front of the Helen Hall Library. The new location is much larger and will provide for more social distancing. The city's Convention and Visitors Bureau has partnered with the Parks and Recreation Department to purchase a 20-foot artificial tree that we can add onto and ultimately get to a 50-foot tree, the biggest in the Bay Area.
