Mayor Pro Tem Hank Dugie – Thank you Mr. Mayor. As Mr. Gross used to say, thank you everyone for being here tonight. We're better when you're participating in your government. As Mr. Johnson said earlier, we, the last two weeks gave out overs 100,000 masks to local businesses. They were overwhelmingly small businesses and very appreciative for just a small amount of masks. The county task force was giving out one month's supply to these businesses. You can definitely tell that the smaller ones are in the biggest need, because when they showed up to receive their masks they were just so very grateful. We've talked a little bit tonight about the vaccine hub that was set up in League City. The county health district is able, if they ever get the doses, to do 5,000 vaccine appointments in a day. In Galveston County we have more than 50,000 senior citizens, people who are over 65. We have at least another 50,000 people with pre-existing conditions that allow them to get the vaccine in this round. There is a demand for it. Every time the application to make an appointment comes out, the system's been overwhelmed. I agree that we need to have some sort of waiting list in place. What we've heard time and time again from the medical professionals and what they've told us to relay to folks is that there will be enough vaccines to go around for everyone who wants it. It's just a matter of when we get it. We're going to continue fighting to get as many doses as we can in a short period of time. We ask that you are patient with us as we make the process better each go around. The medical professionals are also saying please make sure you're scheduling your routine checkups. A lot of people in 2020 did not go see their doctors for their routine checkups and it's starting to have a negative effect on a lot of people. If you're one of those people who have been shying away from your doctor, now is a good time to schedule an appointment. There's a lot of things that can go wrong with you medically outside of Covid. Let's not, due to our fear of Covid, let those other things sneak up on us. I appreciate Mr. Bowman for putting together that PowerPoint. I think there's been some talk about maybe re-branding the Clean and Green Committee to Keep League City Beautiful, so that's really perfect timing. Honestly, I think you'd be a great candidate for that committee. I don't know if you want to be a part of a committee, but if that one gets up and running, I would definitely vote to put you on it. That's it for me. It's a pleasure to serve all of you and to be here with all my colleagues tonight. I look forward to a great 2021. Thank you, Mr. Mayor.

Justin Hicks – I wasn't sure if I was going to have anything, and I hate to beat on the same drum from the last meeting, but remember I brought forward that situation where we were going to re-home a disabled vet. I'm actually pleased to say, from the first handshake to the first dollar raised, eleven days only, we re-homed this man. I really want to say that I appreciate the citizens of League City who stepped up and helped us do that – a couple of council members here. From a very disappointing and divisive 2020 I'd like to say that I think that our community is off to a good start.

John Bowen – I attended the League City Barks and Beads event at League Park this weekend. It was a great event. It seemed everybody there was having a good time. I'd like to thank staff and the Animal Shelter for their hard work and dedication in getting that off

and running. Happy Mardi Gras. Thank you very much for all your work, Sarah and staff and Animal Shelter.

Mayor Hallisey – I have several things. I want to make note of the passing of State District Court Judge David Garner. He was pretty much a lifelong resident of League City. He, for 20 years, sat in the 10th District Court of Texas. He was a great guy. He had been Lion's Club President in this town, President of the Young Lawyers of Galveston County, he was a Park Board member way back in history. He was the guy who gave the legal stuff to the park dedication ordinance and the patrons of the park foundation. He was real involved in League City over the years. He was a descendant of the Butler family, who founded this community in the 1850s. He was one of my two best friends for over 45 years, and he was buried on Friday. It was a very sad event. I mentioned that Deacon Russ did part of his service. His daughter, Shannon, is the volleyball coach out at Clear Springs High School. His two boys live in Austin, and his wife Linda lives across the street from us. Just great people, and it's a sad day. David had a big impact on League City in many, many different ways over his lifetime. I want to also acknowledge the Rotary Plunge. A bunch of crazy Rotarians called around raising money last week so they could go swimming at South Shore at the cold swimming pool. Two of my favorite Rotarians called me and I did contribute to their efforts. They did a great job and I'm sure some of you saw it on Facebook, so good to the Rotary Club. I really want to thank the Clear Creek Environmental Foundation. I was a founding member of that group. Rex Ward, for years, ran it. Mike Stone runs it today, who has the muffler shop across the street. They spend weekend after weekend out cleaning that creek and getting trash out. I think Dave said its, they bring back tons of trash. One of the great assets of this community is that waterway. It is a great place for fishing, a great place for canoeing. Clear Creek Environmental Foundation keeps that clean. We really appreciate that. They are still working this weekend, down at the League City Boat Ramp, 270 between 518 and Nasa One, for anybody who wants to go. If you have a boat, they're happy to have you follow. It's a good deal. That's all I have, so it was a good week.

John Baumgartner – Thank you, sir. I've got a couple of three or four reports. I'd like to highlight some CIP activity. Coming forward in the month of February, we're going to have three-or-four projects bid. We're going to re-bid the West Side Well, the 36-inch waterline that connects Highway 3 to the South Shore Pump Station is important for water redundancy and resiliency of our water system. We're going to have annual sanitary sewer rehab, which is Newport, Ellis Landing and a few other miscellaneous locations. The first phase of the Hike and Bike Wayfinding Signage will bid in February. Then our next two bond projects, I think we talked a little bit about them in the work session, but Bayridge Phase 2, which is the pump station and detention pond will go out to bid in February, come to Council in March. Probably about May timeframe before that gets under construction based on all the pieces and those process for us with public bid and award and that kind of thing. Then the Oaks of Clear Creek, Deer Ridge buyout overland flow drainage project will also go out to bid in February. A couple of projects that are under construction, Calder Road was a GO bond project. The traffic signal and auxiliary turn lanes at League City Parkway and Brittany Lakes and Finnegan and the traffic signalization was awarded in December. The notice to proceed was issued today and should be under construction in the next couple of weeks as they order supplies and materials and get that ready. The Bayridge Phase 3, which is the internal drainage for Bayridge, that was awarded in December, and the contractor anticipates to be mobilized out there in mid-February. More community-wide perspective, we talked about the Beads and Bark in the Park, coming up on February 6 we have the Yachty Gras Grand Night Parade. League City's own All-Hazards Fire Rescue Boat will be the grand marshal of the parade. Yachty Gras is the largest Mardi Gras boat parade in the U.S. and it begins in Clear Lake Channel and passes by the Kemah Boardwalk as boat passengers throw beads to the revelers along the way. There's still time to register your boat for the parade. Go to LeagueCity.com/MardiGras. Secondly, from now until February 28, League City is competing against other cities in the Houston-Galveston area It's Time Texas Community Challenge. All League City residents are encouraged to sign up for the health challenge at League City's website, LeagueCity.com. You can earn points and prizes by taking selfies when you do something healthy. For every League City resident who signs up, League City earns 500 points. Let's all get healthy in the next month and help League City win the challenge. This Friday, tickets are available for the State of the City, hosted by the League City Regional Chamber. This year's event is a breakfast at Hometown Heroes Recreation Center. Mayor Pat Hallisey and I will be addressing the city's successes as well as challenges over the past year and we'll talk about the city's priorities for 2021. Tickets are \$35 and can be purchased online at the League City Regional Chamber of Commerce. Masks and social distancing will be enforced. Again, that's a breakfast event at Hometown Heroes, I think it starts at 8:30 a.m. and ends at 10 a.m. That's all I have for tonight, sir. Thank you.
