Mayor Pro Tem Hank Dugie - Thank you, Mr. Mayor. First, maybe most importantly, the library. Don't forget that July 31 is the last day to record your reading time or book titles, so make sure to do that and claim the prizes you've earned. Teens, be a part of our Critter Crafternoon on Wednesday, July 28 from 5 to 6 p.m. You'll be making terrariums with other teens aged 12-18 years old. On Monday, August 2, adults will be able to enjoy an Antiques Roundtable program with the topic of fountain pens, inkwells and other desk-related items. This event takes place from 1-3 p.m. The library has started bringing story times to a couple of fire stations and the EMS building, and we are excited to be at Fire Station 6 on Friday, August 6. Story time begins at 10:15 a.m. Fire Station 6 is located on South Shore Boulevard. Visit with library staff and the fire fighters and check out what's going on in your community. Next, everyone's favorite topic of discussion in League City, your semi-professional Quidditch team, the League City Legends, is qualified for the championship tournament to be held in Maryland next month. We picked up some wins against New Orleans and San Antonio and punched our ticket to the big show next month. You can follow us on social media and we appreciate all of your support. For those of you looking at me and wondering, Hank, are you still playing? Yes, I'm still playing. I'm going to continue playing until I'm Mayor Hallisey's age.

Last, but not least, to touch on something Mr. Johnson spoke on earlier, the data is showing that people who have gotten vaccinated are better off if they contract COVID. The decision is yours. It's our job just to keep you informed of how the data trends are progressing. Folks who have gotten vaccinated are faring much better if they contract COVID. Just keep that in mind. Andy Mann – I just have one comment. I just want to thank the citizens of League City for the opportunity to serve. Tonight was fun. Thank all of you for participating and making it lively.

Larry Millican - Thank you, Mayor. I've got a couple of issues that I want to talk about this evening. One is going to be a takeaway from H-GAC and dealing with 146. TxDOT has delayed that project, the reach from 518 to 517, with grade separation at 96. They have delayed the completion from '22 to '23. That's because of engineering and permit issues that they have had. I just want kind of wanted to pass that along to everybody here and to the citizens, that there are some issues with that project. Whereas they've been ahead of schedule up on the northern end, but apparently when they got to our end there's a little bit of kink in the giddy-up. The other item I want to talk about is the North Houston Highway Improvement Program. We've got an agenda item on it later, but what I wanted to talk about was TxDOT and a survey that they have out. I sent out to all of council, or I asked Diana to send it out to the council, where you can just click on it and do a Survey Monkey for the North Houston Project. The North Houston Project, for everybody to recall, is that's a section of I-45 that goes from the City of Houston all the way up to Beltway 8. That project has run into a lot of problems with Harris County and City of Houston, the administration of those two entities. Because of some of the activities that they would like to see is out of reach of the ability for TxDOT, they have taken it upon themselves to throw whatever wrenches they can into that project to stop it. TxDOT has now put out a survey that they would like to hear responses on is whether or not they should continue with the project or just stop the project, pull the funding, and take the \$7 billion and go somewhere else in the state with it. I have a problem with that. I think that everyone in Galveston County does. If you look at the evacuation routes out of Galveston County, for that matter, the entire southern region area, all roads lead into the city of Houston. The only road that leads out of the city of Houston is Interstate 45, 288, 146, everything dumps into Beltway 8, and Beltway 8 takes you around to other locales, but I-45 is the only contiguous roadway that goes all the way through the city of Houston for an evacuation process. My stance on the North Houston Project is that whatever has to be

done to relieve the congestion and to improve the capacity for Interstate 45 is something that needs to be pushed forward and that's what this project does. I ask everybody, citizens alike, to go to the TxDOT website, along the first banner that will pop up right at the very top of that website is going to be a survey, and that survey includes a road in El Paso and you don't have to vote on that road, but it does ask you for a vote or an opinion on Interstate 45. I ask everybody to take that and give them your opinion of whether or not they need to continue with that \$7 billion project or not. They will have a virtual public hearing on the roadway plan, August 2, and you can attend that. It's going to be virtual meeting, and I thought that everybody, if you're really interested in TxDOT issues you could certainly attend that public hearing. That's all I have Mayor, thank you.

John Bowen – I just have one thing, Mr. Mayor, and it's the Open Meetings Act. In 2020, the governor allowed exceptions to the Open Meetings Act to mitigate the spread of COVID-19, and accordingly, on June 30, 2021, the Attorney General asked to rescind those exceptions. Starting September 1, 2021, all open meetings must come into back in accordance with the standard Open Meetings Act of Texas. That means all MUD board meetings and any other meeting that's required to have an open meeting. If you have any questions you can contact our legal department. I'm sure they'll steer you in the right direction. Thank you.

Mayor Hallisey – Never to be without something to say, nobody hit on mine. I am really proud, last week I got to go down and address the American Legion Post 554 baseball tournament teams from all around the region. I'm happy to announce to everybody that Post 554 baseball team are now the state champions. They draw kids out of all four of the high schools around here, and they are headed to California for the national regional championship, and we wish them all the luck in the world. Also, the League City Chamber had a business expo last week in this room. It had a couple hundred, or at least my take was, almost a couple hundred businesses showing all their wares. It was well attended. There were lots of people here. Congratulations to Dewan and the chamber for doing a great job. I was gone at the last meeting, but I wanted to throw my two cents in. Other people did it two weeks ago. I want to thank the Parks Department and the Communications Department and all of those who put together a fantastic patriotic event July 3 and 4 for the citizens of this community. Best fireworks show we've ever had in this town in my opinion. The rain held off, God was watching down on all of us. It was fun. Citizens Appreciation Day was fun. I couldn't eat hot dogs, but I saw everybody else walking around eating them. I thought it was pretty cool, and watermelon, and all the other things were going on. It was Americana at its best. The community comes together and celebrates the birth of this country, and we are still the number one social experiment that has ever been created on the face of the earth and I happen to believe we are the best country on the face of the earth. Thank you for all those that worked on July 3 and 4, we appreciate it.

8. REPORTS FROM STAFF MEMBERS

John Baumgartner – Mr. Mayor, before we begin the two formal staff reports I've got a few comments. I'd like to give a report on CIP drainage projects. There are three projects that will be out to bid in August for award in September, one of those is the North Point Detention Pond. The majority of that is funded by FEMA. Bids will open in August on that one. The Bay Ridge Pump Station and Detention Pond Improvements will be out to bid in August with Council action expected in September. The Bay Colony Detention Pond Modifications, advertisement will start at the end of August, with bids open at the end of September, so award is probably anticipated in October. Then, on the League City Parkway and Fennigan and Brittany Lakes intersection, that continues to make progress and proceed as scheduled. That should be completed in October. We've got signal poles up and most of the drainage work done and they're starting to put stuff back together. Then, Hometown Heroes 5K Loop and Obstacle Course, which was awarded previously is scheduled to have a pre-construction meeting August 2 with a notice to proceed on August 9. That should move forward in pretty short order. Lastly, the Deer Ridge Buyout and Overland Flow Project in Oaks of Clear Creek was awarded by Council back in, I'd like to say, earlier in June, and that project, we're going to have a public meeting on August 18 from 5:30-7:30 at the Civic Center. We're going to bring the contractor there and just kind of introduce the contractor to the community as that will be kind of main-and-main in that area of that neighborhood for several months after he gets started. Then, lastly, I'd like to just take a few minutes to publicly recognize Chief Gary Warren, as this is his last council meeting. Gary, if you want to stand up so we can remember what you look like. After 7 years, Gary Warren is going to retire and take charge of all the things Melissa has been saving up for him to do around the house. I understand from talking to her earlier today she has months of work for him rebuilding their home. Not sure what all that means, but that's what she said. I wanted to highlight a few things from Chief Warren's 7 years as our fire chief. During Chief Warren's tenure, League City's population grew nearly 20 percent, from just over 96,000 people to nearly 115,000. Chief Warren worked to enhance service and response time. He developed a stipend program to add day and night crews using our own volunteer firefighters. This program provides the city with at least one fire crew on duty 20 hours a day. It has helped reduce our response times throughout our community. He has fought repeatedly to increase firefighter pension contribution, to recognize our volunteers and improve retention rates in the department. He worked with the Insurance Services Office to obtain an ISO 1 rating for fire insurance premium calculations, saving many of us on our fire insurance premiums.

League City has one of the few ISO 1 ratings in the state. As part of the ISO 1 initiative he located the temporary fire station in the South Shore Water Tower and then led the effort to design and construct Fire Station 6 in the Hidden Lakes area, improving fire coverage in the southeast portion of our community. He developed a program to systematically update the fire and EMS fleet with several new ambulances, fire pumpers and ladder trucks. He expanded and improved the fire training facility, making room for all the new recruits as well as our veteran firefighters. He increased the firefighter recruitment efforts that resulted in our largest cadet classes and allowed us to provide a second annual class. He added a cancer insurance policy for firefighters. He secured hundreds of thousands of dollars in grants for fire, EMS and fire prevention, including a grant for the city's new all-hazard fire boat. He worked to reduce fire plan review time for the development community from ten days to three days. He added and staffed the fourth full-time ambulance, reducing EMS response time citywide. He added the powerload stretchers to the ambulances to improve safety loading and unloading patients and to reduce employee injuries. He uprgraded all the ambulances with UVC light disinfectant systems. He created equitable interlocal agreements for EMS that significantly reduced our cost to other cities and improved collection rates. He improved emergency response times for five consecutive years. Most importantly, Chief Warren has helped build upon the fire department's past successes and prepared us to be ready for what the future brings. For those of you who have not had a chance to say goodbye, tomorrow the fire department is going to host a reception for Chief Warren from 3-6 p.m. at the Fire Administration Building at 555 West Walker Street. It's been my honor to work with Chief Warren and I'd like to give him a warm League City farewell as he and Melissa begin their next journey. Congratulations and thank you Chief Warren, for a job well done.
