Overview:

League City has retained HUB International to provide consulting for its health and welfare benefits plans. The purpose of this presentation is to provide the results of the Stop Loss Reinsurance RFP for the City's Medical Plan and the proposed premiums and employee contributions for the 2021-2022 plan year.

Stop Loss Reinsurance RFP – In conjunction with Purchasing and Human Resources, HUB conducted an RFP for Stop Loss Reinsurance for the City's plan. The RFP was publicly advertised and distributed to all available markets. The most competitive proposal was submitted through BCBS the incumbent provider with a +13.7% increase in premium cost. Alternative proposal submissions were not competitive with proposed increases +50%.

Medical Administrative Services – Medical plan administrative services are under renewal with BCBS and decreased by -1.7% for the 2021-2022 plan year.

Prescription Benefit Management Services – Prescription benefit plan administrative services are under renewal with RxBenefits/Express Scripts. The City's contract includes annually negotiated drug discounts and prescription drug rebate amounts.
