Sarah Osborne – I just wanted to remind everyone we that have a new obstacle course and trail that opened at Hometown Heroes Park last Saturday. It did so with a City Manager 5K Fun Run. I believe out of all city employees, our City Manager, John Baumgartner, came in second place, so he did every well and also placed first in his age category. I wanted to encourage all residents to go on out and enjoy the new obstacle course at Hometown, and the trail. I also want to give a shout-out to my own department. We went to the TAMIO conference this week, which is the Texas Association of Municipal Information Officers. We were presented with seven awards, including a TAMI award for our resident guide. I also want to give a shout-out to the Helen Hall Library, that won an award of excellence for best use of social media and an award of excellence for best use of innovation for their TikTok videos. Congrats to Teresa and her team, who have been pushing the limits of social media and different communication techniques. They are our star department that we have been working with, so we're very proud of them. We also won four other awards for social media, our City Matters magazine and for a flyer that our very talented graphic artist, Ain, actually hand drew herself.

If you haven't heard, we are having our big White Linen night even coming up, next Saturday. I personally invite all of City Council to come on out to the Historic District from 4 to 8 p.m. This started off as hey, we should have an art crawl for the city, and let's see if we can get any artists that would want to have a booth. Well, we have 116 artists that applied to have a booth. They submitted jpegs of their art and our Keep League City Beautiful Committee approved every submission except for one. They will be on display at our art crawl. We will also having an auto crawl, where you will see vehicles from the 60s, when our city was incorporated, as well as other classic cars from the 20s and even 30s on display. There will be multiple food trucks as well as beer and wineries at the event to provide beer and wine, cider and even mead. We have a new mead distillery in League City that will be selling mead for folks to try. It's going to be a really fun night from 4 to 8 p.m. Basically, at League Park and in the Historic District. We're closing down the streets, but it should be pretty awesome. Finally, recently the Texas Department of State Health Services renewed the city's EMS license, placing all EMS certified firefighters and fire marshals with current EMS personnel as one combined unit and one combined force. Basically, when our residents call 9-1-1 this expands our medical manpower on the scene of any medical emergency that our citizens may experience.
