#### 7. COMMENTS/REPORTS FROM MEMBERS OF COUNCIL

Announcements concerning items of community interest. No action will be taken or discussed.

Mayor Pro Tem Nick Long – Thank you, Mayor. The mayor said I did this monotone last time, so I'll pick it up. Take part in our Nutrition Education Class on Thursday, August 11 at the Galveston County Food Bank promoting healthy eating. It goes from 10 to 11 a.m. and is for adults. Learn to take risks and think on your feet through fun improv games. This program is co-hosted by a Teen Advisory Board member. Join us on Tuesday, August 16 from 5 to 6:30 p.m. This program is for ages 12 to 18. Bring your little ones to learn as they use their senses to discover new things in our Little Explorers Sensory Workshop on Friday, August 19 from 10:30 a.m. to noon. This program is designed for ages birth to 3 years. Thank you, Mayor.

John Bowen – Thank you, Mr. Mayor. This last weekend I was at the TML Region 14 meeting that was held in Galveston. The TML is the Texas Municipal League and it's where the cities get together and they share their information with each other about things that are happening in Austin, federal projects, or federal things that are going to affect the individual cities. I have an item on the agenda tonight that I'm going to talk about further that I did get a chance to talk to several elected state officials at this meeting, including a lot of cities. It is for competitive bidding on engineering professional services. Most of the elected officials didn't know we didn't have the ability to actually do a competitive bid. They were very receptive to that information. Also, a lot of the cities thought there was a considerable cost savings in their planning and engineering services and professional services that they could reap from this type of change. It was a very productive meeting. No, I didn't spend the night or go to the beach or anything like that. I'm responsible with your money, but it was a good meeting. Thank you all.

Justin Hicks – Is beep baseball this weekend? Are we going to talk about that? 8:30, Hometown Heroes Park. 8:30 a.m. I'm going to it, so I hope everybody else comes out.

#### Chad Tressler - No comments

Andy Mann – I'm down for some beep ball. If someone wants to put a team together, maybe council versus staff, maybe half the council versus half the staff. I'm sure they'll let us beep ball.

Hank Dugie – Thank you, Mr. Mayor. I just want to thank my colleagues and IT staff for allowing me to participate in our budgeting council meetings while I was abroad. I had a once in a lifetime trip to Tanzania over in Africa. I've been blessed to travel to a lot of different places in my adult life. The thing I'm reminded of every time I return to League City is we truly do live in the greatest society on the planet. We are fortunate to have been born here and been able to grow up here. I'm glad League City's my home. I'm sure you feel the same way. I've had great experiences in other countries, but there's none quite like being home in the United States. Moments of reflections with Hank, thank you, Mr. Mayor.

Larry Millican – Thank you, Mayor. Well, same topic that I talked on the last time. Signs. Political signs. The sign fairies have arrived. After the political filings we now have more political signs out in places where they shouldn't be. It's pretty easy, simple question you need to ask – who gave you permission to put the sign where you put it. It's just that simple. If nobody gave you permission, it's probably in the wrong place. People want to say well it's a drainage right-of-way or a drainage easement, or an electric right-of-way or an electric easement, roadway right-of-way, but let me just say it's very easy. The law is pretty clear. If you put a sign up, you need to have the owner's permission. If you have the owner's permission, you get to put it up. If you don't, you shouldn't put it up. There's obviously a lot of signs around this city that no one got permission, because the state won't give you permission, the city won't give you permission. I can't speak for some of the electrical right-of-ways or gas lines, but let me say that I know those two won't give you permission. I, for one, would like to make sure that signs are put out where they should be and removed where they are not supposed to be. Thank you, Mayor.

Mayor Hallisey – A couple of things, I am going to beep baseball at 8:30 a.m. Bright and early. I also have to be out at Lynn Gripon Park at Countryside because the great canoe challenge is taking place, coming down from Friendswood and ending at Lynn Gripon Park, which is another cool deal. For you old people like me you'll remember, well anyway, his band Cool Beans always plays out there. He's a really nice guy. Janice and I did a project with him in Galveston a long time ago. It's a good time had by everybody, a good place for League Citians and Friendswoodians to get together and sort of share in some good times. It's one of the cool things that happens on the creek. I did it one year, I'll never do it again. I thought I was going to die. I'm sure I went to the hospital for oxygen, but these kids are all young and they're used to doing it. A couple of other things real quick. On the 30th, and this is as much for everybody at this table as citizens in town. On the 30th, as a

region, we are all going up to the TxDOT board meeting. We are, once again, as we did several years back, trying to express to them our strong desire to get off this merry-go-round of the Grand Parkway. We need that to come through if for no other reason, than to make Mr. Mann happy that he can get out of his neighborhood and get to work in the morning, but equally as important, when that Grand Parkway is finished, not only will we have the ability to go north, east and west to escape the storms that come into this coastal prairie, and we have seen our share of all of this. We're doing what we can to stop flooding, but we need to get out of here when the time comes because water kills. Rain does not, but water kills. It's really important. We are going up. Most of the mayors and council members from the region will be going, and a lot of the big businesses here will be going once again. If you did not write a letter, if you weren't part of the chain to write a letter to TxDOT, call our office in the morning, we'll give you the address to let them know how important this highway is to the people of League City, Galveston County and the region. We're trying to get it done. The city has done a lot of roadwork over there. It's all going to connect to 517, or the Grand Parkway sooner or later. John's laid out a good plan internally for us to move people. We just need the major highways. Sixty-five percent of our working population in League City goes to the northwest corner of Harris County, which is where the energy corridor is. We'd love to have all these people working down here in the region. Commercial development has been the battlecry for all the years that I've been here, but we have not made a dent in that. We get some, but we have not made a big dent. It's going to happen because the big gorilla up north is coming south. It's been League City's mainstay for the 50 years I've been here. It's just grown like crazy. Every time I see the mayor of Houston, he said how are things in the 'burbs? I said you know, as long as you keep growing, we keep growing. It's just the way it is. We're happy with here we're at. We know we're going to double in size in the next 25 years. We know where it's going to be. It's all going to be along the Grand Parkway corridor, which will help. I-45, since I was 5 years old, which was 67 years ago, they've been working on that freeway. They're going to always work on it. It will never carry the load to get us out of the way of major storms. The highway department has got the funding. It is a toll road. We've made this case time and time again up there, but we are going to go back because we'll never give up until we are able to relieve some of this major traffic stuff. Also, for those of you who are interested in that stuff, BayTran, Bay Area Transportation, is having a meeting, a luncheon, at the Marriott up by Airport Boulevard on Thursday, 11:30 to 1. Most everybody that's involved in this will be there. A lot of good discussion, plus TxDOT Commissioner Laura Ryan will be there. Who's coming with her? Eliza Paul, who lives across the creek from us but she's the district engineer and a fine person. If you have an interest in Grand Parkway stuff, it's a good place to go.

#### 8. REPORTS FROM STAFF MEMBERS

John Baumgatner – The whole conversation on west side traffic is a great segue into what's going on and the conversation about I-45 being under construction forever. Our section of I-45 is continuing to wrap up. TxDOT still is predicting the section between 518 and Dickinson to be complete right around the end of the year, and then the section that is so important, when you get on 45 between 518 and Nasa One, is probably early in 2023. Weather permitting. We've had this long spell of dry weather, the contractor continues to make good progress. Starting September 6, TxDOT is going to start one of their last phases. It will affect west side traffic. They're going to reconstruct the interchange, underneath the freeway on 518 from Wesley Drive to Hobbs Road. While it won't be a total closure, it will close it down to essentially one lane each direction with some left turn lanes at the freeway. They predict it will be four different phases. The first couple of phases are the toughest, and will take, they're estimating 90 days, but let's just say it starts September 6 and by the end of the year that construction should be mostly complete. As I talk about construction and congestion and that kind of thing, if you can use an alternate route, take one. If you can't, please allow extra time. It will be much like when they reconstructed 646, that was a total closure. Obviously, there's more traffic on 518. Then we went through the reconstruction of 96 a couple of years ago. While we are seeing the end of it we have one more tough spot and that's the interchange at 518. That's coming starting September 6. They will do construction seven days a week and the stuff they can do at night they'll do at night. It'll be a rough end of the year. We should start seeing our part of the freeway look much like the portion that's just north of us. Good news for that. If you have travel further south, you work in Galveston or something like that, you have years of construction to go through. It's unfortunate, but we're still rooting for the Grand Parkway to help alleviate some of that. Then one more quick announcement. The registration for League City University is open. It's a 10-week period. It's Thursday from 6-8 p.m. Each session includes an interactive presentation from city staff on various city services and issues. For more information talk to our Community and Special Events Coordinator, Ashley Jackson and that's on the website. Again, League City University, I know there are a large number of people that have taken it, usually 20 people each time. It's a great class and a great way to get to know folks on the staff, put faces with names and learn a lot about how city operations work. If we have time I think they have a brief video about dispatchers. (Video Plays) As the council knows, we have struggled a little bit with recruitment on the dispatcher side, the police side, frankly a lot of different city positions. Dispatching is one of those callings. It is a 7 day a week, 24-hour operation, they work in 12-hour shifts, either nights or days. That's all I have tonight, sir.
