The District has constructed certain water, sanitary sewer, and drainage facilities and is formally conveying the facilities to the City pursuant to the utility agreement approved on September 23, 2003 (Ordinance 2003-53, first amended on March 28, 2006 (Ordinance 2006-17), and amended a second time on October 24, 2006 (Ordinance 2006-96). Subject to a security interest retained by the District, the agreement requires that these facilities be conveyed to the city for ownership, operations and maintenance.
