Consider and take action on an ordinance formally adopting the various charter amendments that were approved by a majority of qualified voters during the November 6, 2018 charter election (City Attorney)

Staff recommends approval on first and final reading.

Approval of this item will formally adopt the various charter amendments from the November charter election. On November 6, 2018, the City of League City, Texas conducted a special election concerning several proposed amendments to the City Charter and a total of of 38,872 ballots were cast.

Each voter received one (1) ballot for the propositions from which each of the propositions received the following number of votes:

As required by the Texas Election Code, the City canvassed the returns of the November 6, 2018 special election on November 22, 2018 through Ordinance 2018-43. Ordinance 2018-43 did not contain the finalized language that will be included in the Charter.

Under Section 9.005 of the Texas Local Government Code, a charter amendment does not take effect until the governing body of the municipality formally enters an order in the records of the municipality declaring that the charter amendment is adopted. Staff recommends approval of this ordinance, which formally enters an order in the records of the City declaring the charter amendments adopted and contains the finalized language that will be included in the Charter.
