Approval of this resolution will authorize the City Secretary to publish Notice of a Public Hearing to consider adoption of Capital Recovery Fees for Water and Wastewater Facilities and direct the Capital Improvements Advisory Committee (CIAC) to consider and make recommendations on the Capital Recovery Fee Report.

As outlined in Chapter 395 of the Texas Local Government Code, a City, wishing to consider the adoption of impact fees, must establish a Public Hearing date within 60 days of approving this resolution. Staff wishes to hold this public hearing on April 9, 2019 as part of the scheduled City Council session. A Public Notice for this Hearing would need to be published no later than March 8, 2019.

The Water and Wastewater Capital Recovery Fee ties to the City's Strategic Plan Critical Success Factor #1 (Develop and Maintain our Infrastructure), Initiative #1 (Develop and Maintain our Infrastructure), sub-items #A, E, G, H, I, and K.
