Consider and take action on a resolution awarding a construction contract to Tandem Services, LLC for Phase 1 of the Walker Street Corridor Upgrades project (ST1803) in an amount not to exceed \$267,119.90 and authorizing an expenditure of an additional \$26,000.00 for a construction work change directive budget (Director of Budget and Project Management)

Approval of this resolution will authorize the award of a construction contract with Tandem Services, LLC in the amount of \$267,119.90 for Phase 1 of the Walker Corridor Traffic Upgrades project (ST1803). This project is fully funded by TIRZ #2 and the board approved this construction award at their July 23<sup>rd</sup> meeting.

The boundary of this project is along Walker Street between League City Parkway and FM646. Phase 1, being considered tonight, includes adding two left turn lanes and one right turn lane associated with the driveways entering Victory Lakes Intermediate.

To follow this construction, Phase 2 will include additional turn lanes and other miscellaneous improvements along Walker Street, while Phase 3 will install 3 new signals (Kesslers Crossing, Victory Lakes and the Lowes intersection) and modify the existing signal at FM646.
