Consider and take action on a resolution authorizing a construction contract with Lucas Construction Company, Inc. for the 3<sup>rd</sup> Street Asphalt Street Rehabilitation Project (RE1704G), in the amount of \$670,789, authorizing the expenditure of an amount not to exceed \$67,079 for a work change directive budget, and authorizing a construction materials testing contract with Terracon in an amount not to exceed \$14,811, for a total construction budget of \$752,679 (Executive Director of Finance & Project Management)

Approval of this resolution will authorize the award of the construction contract to Lucas Construction Company, Inc. for the construction of the 3<sup>rd</sup> Street Asphalt Street Rehabilitation Project (RE1704G), authorize funds for a construction work change directive budget, and authorize a materials testing contract for a total construction budget of \$752,679.

The purpose of this project is to perform road base repairs and asphalt resurfacing as part of an annual infrastructure reinvestment program. This project includes 3<sup>rd</sup> Street between N. Wisconsin and Alabama. This project is part of the City's reinvestment of CDBG funds into the community.

Five sealed bids for the project were received on September 21, 2021 (Bid No. 21-044). Bid analysis was based on A+B bidding, which factors time plus cost to determine the lowest equivalent bid. Lucas Construction Company, Inc. submitted a base bid in the amount of \$670,789 and 120 days. The engineering consultant's recommendation of award and the bid tabulation are attached.

Construction of 3<sup>rd</sup> Street is programmed in the FY2022-2026 CIP as part of the Asphalt Rehabilitation Project Package 6 with an inclusive budget of \$2.3 million. Engineer consultant's cost of construction for RE1704G was estimated at
