

RESOLUTION NO. 2026-

A RESOLUTION OF THE CITY OF LEAGUE CITY, TEXAS, AUTHORIZING TWO AGREEMENTS WITH MIKE PIETSCH, P.E. CONSULTING SERVICES, INC. FOR THE PURPOSE OF CONDUCTING A REVIEW OF THE CITY OF LEAGUE CITY'S PROPERTY PROTECTION CLASSIFICATION FOR AN UPCOMING INSURANCE SERVICES OFFICE AUDIT FOR TOTAL COMBINED AMOUNT NOT TO EXCEED \$78,500; AND PROVIDING FOR RELATED MATTERS

WHEREAS, the City of League City, Texas (the "City"), desires to obtain professional consulting services to conduct a review of the City's Property Protection Classification (PPC) in preparation for an upcoming Insurance Services Office (ISO) audit; and

WHEREAS, the Insurance Services Office evaluates fire departments through the PPC Program on a periodic basis, typically every three (3) to ten (10) years, and the City's last ISO audit was completed on December 19, 2016, with a Class 1 rating effective September 1, 2017; and

WHEREAS, the City is now due for a subsequent ISO audit, making a comprehensive review timely and necessary to help preserve and potentially improve its current classification; and

WHEREAS, the City has negotiated agreements with Mike Pietsch, P.E. Consulting Services, Inc. to perform such services, and the City Council finds that approval of these agreements serves a valid public purpose and is in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LEAGUE CITY, TEXAS, as follows:

Section 1. The City authorizes two agreements with Mike Pechev, P.E. Consulting Services, Inc., attached hereto as Exhibit A and Exhibit B, for purposes of conducting a review of the City's Property Protection Classification in preparation for the upcoming Insurance Services Office (ISO) audit, in a total combined amount not to exceed \$78,500.

Section 2. The City Manager, or his designee, is authorized to execute any documents or agreements necessary to complete this transaction.

Section 3. All resolutions and agreements and parts of resolutions and agreements in conflict herewith are hereby repealed to the extent of the conflict only.

Section 4. It is hereby found and determined that the meeting at which this resolution was passed was open to the public and that advance public notice of the time, place and purpose of said meeting was given as required by law. This Resolution shall take effect immediately upon its adoption.
