### RECITALS

WHEREAS, the parties entered into an Agreement ("Agreement") on or about April 12, 2023 whereby Contractor agreed to provide Relocation Services for the North Landing Extension Project (ST1914); and

WHEREAS, the parties wish to amend the Agreement to increase the total compensation under the Agreement by \$114,450 due to additional relocation services to complete all the relocations,. and extend the termination date of the Agreement to May 31, 2025.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree to the following terms:

### TERMS:

- 1. The above-listed recitals are true and correct and hereby incorporated into this Amendment.
- 2. The total compensation under the Agreement is increased from \$94,150 to \$208,600.
- 3. The scope of services is increased as described in Exhibit A-2, which is attached and incorporated herein.
- 4. The termination date under the Agreement extended from May 31, 2024 to May 31, 2025.
- 5. Except as expressly provided in this Amendment, all other terms, conditions, and provisions of the Agreement shall continue in full force and effect as provided therein.

Obtain 2 moving bids. Order funds to pay tenant all eligible moving expenses. Inspect site when tenant vacated. All documentation to be completed on forms that were URA-compliant on prior projects.
  \$350.00 per unit
- <u>14 Business tenants</u> Meet with tenant to provide introduction letter, advisory services to minimize impact, advice on potential benefits, conduct inventory, deliver 90-day notice and subsequent 30-day notice. Obtain 2 moving bids. Order funds to pay tenant all eligible moving and reestablishment expenses. Inspect site when tenant vacated. All documentation to be completed on forms that were URA-compliant on prior projects.
  \$7,500.00 per business
- 3. 50% of the fee due after 30 days upon delivery of the 90-day letter, the balance due when relocation is complete or when time period for reimbursement of relocation benefits has expired.



4. Additional fee may be necessary if it is determined that the U-Haul business is eligible for relocation benefits. For instance, a manager resides on-site.
