






Comments and Big Ideas Boards




Proposed Projects Map








Markup Maps

Appendix C: Recommended Funding Source Descriptions

Category 6A and 6B: On-system(6A) and Off-system (6B) Bridge Program Funds. Category 6 funds are federal dollars set aside to rehab or replace structurally deficient or functionally obsolete bridges. Category 2: Corridor Funds. Funds allocated to mobility projects that add capacity to state facilities in metropolitan areas.

Category 3C: National Highway System Funds: Rehabilitation. Funds allocated towards the rehabilitation needs on non-interstate portions of the national highway system in Texas.

Category 4A: Surface Transportation Program (STP): Safety. Federal funds allocated to safety projects under the Federal Hazard Elimination Program (FHEP) and the Federal Railroad Signal Safety Program (FRSSP). FEHP funds can be used on all public roadway except interstate highways. FRSSP can be used to fund highway-rail grade crossing safety projects on any public road.

Category 4B: STP Transportation Enhancements. These funds are allocated to projects beyond the scope of typical highway project and include projects such as bike and pedestrian amenities, landscaping, historic preservation, highway environmental pollution mitigation, etc.

Category 4C: STP Metropolitan Mobility/ Rehabilitation. Funds allocated towards mobility projects in within MPO boundaries with populations above 200,000. These funds can only be used on roadways classified higher than a rural minor collector.

Category 4D: STP Metropolitan Mobility/ Rehabilitation. Funds allocated towards mobility projects in areas with populations between 5,000 and 200,000. These funds can only be used on roadways classified higher than a rural minor collector.

Category 4F: STP Rehabilitation in Urban and Rural Areas. Funds allocated to on-system facilities in rural and urban areas for the rehabilitation of main lanes and structures. Can be used on roadway classified higher than a rural minor collector in a non-urbanized area.

Category 4G: STP Railroad Grade Separations. Funds allocated towards the replacement of deficient railroad underpasses and construction of grade separations on state facilities. Can be used on roadway classified higher than a rural minor collector in a non-urbanized area.

Category 5: Congestion, Mitigation, and Air Quality (CMAQ). Funds allocated towards projects in non-attainment areas designed to improve air quality by reducing congestion. Projects selected for these funds must demonstrate an air quality benefit.

Category 10A: Traffic Control Devices. Funds allocated towards the installation and/or rehabilitation of non-interstate signs, pavement markings, lighting, and traffic signalization.

Category 10B: Rehabilitation of Traffic Management Systems. Funds allocated for the maintenance and rehabilitation of operation traffic management systems. These funds cannot be used to for the installation of new traffic management systems.

Category 11: State Discretionary Funds. Funds miscellaneous projects located on on-system facilities at the district's discretion. These funds cannot be used for right-of-way acquisition.

Category 12: Strategic Priority Funds. Funding allocated to projects (selected by the transportation commission) that promote economic development, provide system connectivity with adjoining states and Mexico, or other strategic transportation needs.

Highway Bridge Program – Federal funds designated for the replacing or rehabilitating structurally deficient or functionally obsolete bridges on public roads.

Proposition 1: Texas Constitutional Amendment for Transportation Funds: Gas Tax Funds. State funds designated for the construction, maintenance, rehabilitation, and right-of-way acquisition for non-tolled public roads.

Poor city design and planning, incl. timing of far too much simultaneous construction.

Too many vehicles on 518 and League City Parkway to get to places in a timely manner.

The roadways are not being modified to incorporate all the additional homes, and especially apartments, being built. It is already congested without the additional families coming to the area.

bike paths are very limited

Much improved in recent years with more new turn lanes, 5 corners and now 518 at I-45. Traffic light synchronization has helped a lot too.

Because the city is allowing developers to build too many rooftops and adding more vehicles in the city.

Mostly bc of TxDOT projects that are taking forever to be completed.

Few Synchronized traffic lights and difficult to plan for time to travel in that the loads are very spotty (school times)





Construction on both 45 and 146 has resulted in increased traffic along other routes that is exacerbating all other known issues.

There are a few bottlenecks that significantly slow traffic

Heavy congestion during peak hours

Because citizens are increasing so is traffic. FM 270 needs to be widened south of 5 points.

Where walking and biking infrastructure exists (518 south/east of 5 corners, 270 North of 5 corners) it's great. Getting to old League City, or up and down highway 3, or lots of other places isn't super safe on a bike or on foot.

Need more bike routes. Kids can't get to school safely because neighborhood/back roads aren't connected or require navigating a maze of turns and the primary thoroughfares have too much high-speed traffic. There are more bike paths getting built, but really need them to allow you to go to actual destinations like school, the library, YMCA, local businesses/restaurants/ice cream shops, etc.

I can rarely make simple commutes without traffic problems.

It seems like every where I drive is under construction I live in landing nightmare

Congested traffic

The traffic lights have not kept up with the population increase

Getting anywhere in League City is really hard because of increased traffic and inadequate infrastructure.

Traffic is getting worse every year.

Road capacity cannot keep up with population; public transportation is functionally non-existent; no transportation links with Greater Houston beyond roads

Roads are congested, with not enough sidewalks, crosswalks, and bike lanes. The population is large enough to support mass transit options.

Neighborhoods have become the detour route for many travelers. Neighborhoods such as South Shore Blvd between 96 and 646 cannot handle safety without more than 1 stop sign

Car oriented development has led to insurmountable traffic congestion.

We have multiple chock points around town like 5 Corners. The West side needs north / south flow badly.

No public transportation, sidewalks don't exist or don't connect. I45 divides city and intersections are always under construction and can only be crossed in a car

Would be excellent if not for 45 construction.

I feel that League City has to many projects going on at the same time.

Several severe bottlenecks and choke points, mostly surrounding access to IH45

Too much traffic

Too much construction and too trucks on the road

Construction has been ongoing and little thought given to the affect on traffic.

Need to finish the dang construction on I-45

Roads are overcrowded most of the time

Depending on day and time of day it's either very congested. Or smooth sailing.

League City has become too overpopulated and the roads can't accommodate the current number of vehicles on the roads on any given day/time

Roadway congestion, poor stoplight timing, no alternate travel paths (bike/walk) spaces

There are streets around goforth elementary that need sidewalks for kids to safely get to school. The current path the city thinks the kids should use are not safe bc of too many unmonitored intersections such as Roma@Austin then Austin@ Tuscan lakes blvd and again at Austin@Louisiana. Sidewalk on Webster all the way thru. Webster needs to be expanded with two schools being on that street.

Generally speaking traffic is reasonable, with the exception of Egret Bay, 518, and 2094.

Excessive congestion due to poorly planned roads

Safe passage for kids getting to school is not existent. The district has decided that kids within 2 miles of the school cannot get bus service no matter the route through unprotected intersections. Intersections outside of the school zone are not monitored for children. No care given for children from age 5- 18 to get to and from school safely.

Continued delays with projects on 518 and league city parkway result in congestion during peak hours that could be mitigated with the completion of these projects.

No public transportation, a lot of traffic

Bay Area and 518 is a shit show in the mornings for L onto 518, backing up really far into Rustic Oaks. The opposite direction is a nightmare in the later afternoon rush hour because the L turn lane is far too short so it backs up, blocking the middle lane folks from actually approaching the light. Plus there is the daycare there and those parents struggle to get out after pick up because the traffic is backed up so far down Bay Area. I also avoid E LC as much as possible because the traffic is awful even in the middle of the day on every main road.

Bay Area Blvd & Draffic on Bay Area SB on to 518 EB is frequently congested. There used to be a flashing yellow arrow for that turn, but it hasn't been present in years. There's rarely much straight NB traffic on Bay Area at that point, so it would ease the situation if that yellow arrow were returned. Bay Area traffic is relatively low-speed at that intersection.

Conversely, at the same intersection, but regarding the left turn from EB 518 onto NB Bay Area: This now *does* have a flashing yellow arrow. But, traffic in both directions on 518 is usually heavy, and quite high-speed. I've personally witnessed several high-speed, close-calls there lately.

Bay Area Blvd and 518 needs a designated Right turn lane (going south on Bay Area) and double left turn lanes to handle traffic.

More designated right turn lanes need to be added to all major road ways in league city. Coming to a complete stop to make a R turn when there are drivers going 45mph behind you, is not safe.

South Shore harbour- Crosswalks that help pedestrians cross safely are closest to the Kroger-which is good. Limited crosswalks getting to park, which is a concern for children and young adults' safety as people speed on this road frequently.

Southshore at 96, right turn only lane is idiotic. Only one lane can go straight to access 2 shopping areas, a large neighborhood, 3 schools and 646. Who thought that was a good idea?? 518 at 45 is a disaster. It was supposed to be finished by January.

SSH blvd and 518 - clinking yellow light for left turns from 518 to SSH blvd is not safe. The turn is too long and the visibility of oncoming traffic is too limited.

The 400 block of Bay Sky Drive has no lights and no sidewalks for pedestrians to walk on. This stretch runs from 517 to Colony Ridge Ln. Pedestrians have to enter the roadway to walk this stretch of roadway and I have witnessed several near misses while traveling this roadway.

The 5 corners

The 5 Way Stop is a disaster during rush hour. A flyover for North and Southbound Egret Bay Dr. would be a huge relief for this intersection.





The place in front of Red River Barbecue and Kroger's on Egret Bay has always concerned me, I'm afraid that an accident could happen there.

The roadways on the east and west side of Cross Colony blvd the speed limit is 25. On Cross Colony the speed limit is 35. There are hike and bike trails on both sides of the roadway and homes facing the road. We know that the PD dosent enforce speed violations until more than 10 mph over the limit so cars are now traveling 45 on Cross Colony. I feel that all residential speed limits should remain the same at 25 mph for safety reasons. Please look into lowering the speed limit to 25 mph on Cross Colony blvd.

The signal at Marina Bay dr. and Egret blvd. could be improved as far as signals and turning arrows. Having a safe way to travel on bike on Marina bay dr. betyween Glen Cove Blvd and Lawrence rd. (no sidewalks or bike path)

The turn lanes between Kroger and HEB on Hwy 96 are death traps. There's no visibility around everyone's big pick-up trucks in the opposing turn lane, and people will pull through the wrong one to cross traffic.

There are very few roads in the city that could be considered safe. They are all far too wide leading drivers to feel safe speeding and putting pedestrians/cyclists at risk.

There is a lot of congestion at the intersection of 270 and 5 corners. It makes it hard for people to cross from Barger to 270. Maybe a traffic light at either Barger or Coryell would help.

There needs to be more traffic control in and around the Pedregal neighborhood. The speed limit on Pedregal is 35, which is already high for a neighborhood street with multiple houses/driveways, but people are constantly driving 40+. There also need to be traffic control on Muldoon Pkwy, where there are no speed limit signs and a couple of stop signs that are repeatedly ignored. These are huge safety concerns.

Construction projects take way too long from start to finish. Need to speed this up and factor in the opportunity lost cost to citizens!

Coordination construction projects with other local jurisdictions to reduce the amount of time all of the major streets and roadways are hit with construction delays.

Curb cuts (or lack of) in poor condition or too small make access for wheelchair users and those with strollers very difficult. The Landing has almost no curb cuts. Some of them that do exist in other places are far too narrow to allow a typical wheelchair user to maneuver properly because they're far too narrow with awkwardly high curbed sides. Old LC is supposed to be walkable and family friendly but crossing Main St with kids is a nightmare and the sidewalks are uneven or don't exist.

Depending on the buildings being built at Link road, it may get difficult to get out of the neighborhoods on Calder. Now, when 45 is closed for construction and people use Calder it is almost impossible to get out of the neighborhood without pulling out in front of someone. People do not go 40 miles and hour so that you can catch a break. On these days people go anywhere from 20 - 40 making it impossible. When someone calls the police and they sit and monitor speeds drop to 20 - 30 mph. While some people do speed, there are actually more people going below the speed. The City has granted permitting for building but I don't think they have considered what it does to exiting the neighborhoods on the street, particularly the neighborhoods whose only exits are onto Calder.

League City did a poor job of planning when the major home developments started in the 1970's and 1980's. The city should have planned for a grid of roads to allow cross town travel through developments. This is still true today for new developments, but difficult to correct in developed areas now.

League City does not care about public transportation at all. Making League City a prominent link in a regional transportation network including Houston and Galveston would make it an extremely attractive place, especially as the city is trying desperately to preserve its status as a bedroom community.

League City needs to incorporate a fixed route bus system/collaborate with Public transportation providers! Our city has over 100, 000 people living and working in it. We have a substantial disability community and many seniors who want to stay engaged in community life. Public transit will also decrease congestion from number of drivers on the road!

League City Pkwy through Westover Park needs the planned two additional lanes now. It would reduce traffic on Westover Park Drive which is usually at over the speed limit and congested during rush hours. Westover Park Drive has substantial foot and bicycle traffic. Also, it does not have a traffic light at 518. More lanes on League City Parkway will encourage traffic to go to Maple Leaf and Bay Area Blvd instead.

Left turn lights are often way to short for the number of cars turning, forcing multiple light rotations. Motorcycles don't always trigger lights.

The sections of the hike/bike trails I've used are great. It's a cool feature of our city, but it doesn't seem to get as much promotion or attention as it deserves. One thing that might help: Give more neighborhoods safe access to the trails - even if some of those neighborhoods have a few residents who oppose it. How nice would it be if kids could hop on their bikes to go to/from school without having to cross 4 or 5 lanes of busy traffic?

The way the city is developing is unsustainable and will just lead to future traffic, congestion, and safety issues. The current solution of widening roads and adding stoplights will not be sufficient for addressing the increasing population. Alternative development patterns need to be explored and transportation alternatives need to be implemented to get less cars on our streets.

There is a general appearance that the traffic situation is not important. I seldom see PD in the neighborhoods and especially near schools. Parking for school events poses challenges for citizens living in the immediate area of the school. Hyde elementary causes such problems that emergency vehicles cannot travel from FM 518 south on South Laguna Pointe Drive during a school event!

Something I Would Change

Grass median needs to be narrowed and remove curb adding concrete approaching intersection light, as cars trying to turn left at light cannot get over left due to cars in front of them trying to go straight at the light. This happens during busier hours.

I would love to have a bridge here that connects 270 to the flyover going to 45 it would take so much traffic off 270 and NASA Rd 1 and be a much quicker way to get to 45 for those of us on the east side of league City. Thanks

Bad congestion heading N and NW at the HWY 3 and FM 518 intersection during rush hour.

This road has become a cut through for many, including dump trucks, from 517 to Hobbs, and is being treated as a highway. This is a residential street that families can't even let their kids play outside due to the consistent speeding down this road. Speed limit is currently 35 mph, which should be lowered and enforced. Many people cutting through are doing 45+ mph.

After 3 years of I-45/FM646 intersection construction, this intersection is still horrible. Due to the way TXDOT designed the concrete medians and allowing people to turn left after the intersection (west of I-45), it basically negates the additional 2 left turn lanes and 1 right turn lane. It is still a bottleneck due to the way this was laid out.





There needs to be a caution yellow on the light to get on the flyover from Hwy 3. Many times the light is red and no one is coming but there is a long line of cars waiting to turn.

The most unsafe way to make us turn left off of link road. I drive it daily and have seen so many accidents and almost accidents happen here. This part of the city is so busy and for anyone needing to turn left, it's 1. Not safe to frogger to the middle of the road to wait there until you can go 2. If traffic headed right towards the freeway is backed up, they don't leave an opening for people turning left to go 3. There is too much traffic coming out of link road to warrant only a stop sign.

Needs to be a 4 way stop. Too many wrecks and speeders.

The growth east of the 5 corners causes this intersection to back up significantly every day. At times, it can take 25min just to clear the corners. Is there a way to create a roadway along the creek that allows people to access NB Egret Bay Blvd? This would alleviate a significant amount of vehicles continuing on to the 5 corners and make it safer for the kids at CCHS and CCI.

Either TXDOT or HEB or city needs to redesign the turn in at this location into shopping complex. The median needs taking out as the turn in is too sharp and traffic going all directions at stop signs as soon as you turn in. Too much confusion going on. Wrecks imminent.

Sidewalk needs to be extended from here to Lawrence.











Two Lane Collector with Unstriped On-Street Parking – 80 Feet of ROW








Two Lane Collector with Striped On-Street Parking – 80 Feet of ROW



Two-Lane Divided Collector with On-Street Parking – 90 Feet of ROW









Six-Lane Major Arterial Intersection with Single Right and Left-turn Lanes - 140 Feet of ROW



Six-Lane Major Arterial Intersection with a Single Right-Turn Lane and Dual Left-Turn Lanes $\,$ - 140 Feet of ROW




Six-Lane Major Arterial Intersection with Dual Right and Left-turn Lanes - 140 Feet of ROW








Four-Lane Major Arterial Intersection with Single Right and Left-Turn Lanes - 120 Feet of ROW


Four-Lane Major Arterial with Shared Use Pathway – 100 Feet of ROW
