Title

Consider and take action on a resolution authorizing the purchase of two (2) EMS public safety replacement vehicles with emergency related equipment from Caldwell Country Chevrolet through BuyBoard Contract 601-19 and MAL Technology Fleet through BuyBoard Contract 698-23 in an amount not to exceed \$121,044 (Director of Public Works and Fire Chief)

..Background:

Approval of this resolution will authorize the purchase of two (2) EMS public safety replacement vehicles with emergency related equipment from Caldwell Country Chevrolet through BuyBoard Contract 601-19 and MAL Technology Fleet through BuyBoard Contract 698-23 in an amount not to exceed \$121,044.

On February 28, 2023, Council approved Resolution Item 2023-41 under agenda item 6L for replacement purchases of public safety vehicles. Included in this resolution was the approval to replace EMS Units 233 and 235 with Ford Interceptor Explorers and emergency related equipment in the amount of \$121,458. Although purchase order 2230777 has been submitted to Silsbee Ford as of now the vehicles are still pending Ford's order bank to open.

Caldwell Country Chevrolet reached out to EMS indicating they have two 2023 Chevrolet White Tahoes available for purchase under BuyBoard Contract 601-19 and has agreed to price match the Ford Explorer quote of \$44,610 per unit from Silsbee Ford. MAL Technology Fleet will provide the upfitting and installation with necessary emergency equipment under BuyBoard Contract 698-23 in the amount of \$15,711.65 per unit for a total cost of \$121,044.

Due to on-going supply chain limitations and expected 12-to-18-month lead-time deliveries from Ford, staff recommends purchasing these units from Caldwell Country Chevrolet with an estimated delivery time of approximately 180 days in an amount not to exceed \$89,620, which includes the \$400 cooperative contract fee, and MAL Technology Fleet's upfitting of the necessary emergency equipment in the amount of \$31,424 for a total purchase cost not to exceed \$121,044.

Staff further recommends retaining the order for the two Ford Interceptor Explorers purchased through Silsbee Ford to be used for the replacement of two of the public safety units proposed in the FY2024 budget.

The total purchase cost for EMS replacement units, including the \$400 BuyBoard purchasing fee, will not exceed \$121,044. The vehicles, emergency equipment and installation costs will be purchased through BuyBoard contracts and meets formal bidding requirements.
