## ORDINANCE NO. 2025-53

AN ORDINANCE APPOINTING JUDGE DICK HOSKINS GREGG, III AND JUDGE RICHARD COPE AS THE ASSOCIATE JUDGES OF THE MUNICIPAL COURT OF RECORD IN THE CITY OF LEAGUE CITY FOR A TWO-YEAR TERM BEGINNING FEBRUARY 1, 2026 AND ENDING JANUARY 31, 2028 AND APPOINTING JUDGE SHARI GOLDSBERRY AS ASSOCIATE JUDGES FOR THE MUNICIPAL COURT OF RECORD IN THE CITY OF LEAGUE CITY FOR A TWO-YEAR TERM BEGINNING JANUARY 1, 2026 AND ENDING DECEMBER 31, 2027

WHEREAS, Chapter 30 of the Texas Government Code, as adopted by the City of League City, authorizes the creation and operation of a Municipal Court of Record and the appointment of municipal judges and associate judges; and

WHEREAS, Section 30.00006 of the Texas Government Code provides that the governing body of a municipality shall appoint the judges of a municipal court of record by ordinance; and

WHEREAS, the City Council of the City of League City finds it necessary and appropriate to appoint associate judges to ensure the efficient and continuous operation of the Municipal Court of Record; and

WHEREAS, the City Council desires to appoint Judge Dick Hoskins Gregg, III, Judge Richard Cope, and Judge Shari Goldsberry to serve as associate judges of the Municipal Court of Record for the specified terms.

NOW, THEREFORE, BE IT ORDERED BY THE CITY COUNCIL OF THE CITY OF LEAGUE CITY, TEXAS, that:

Section 1. The City Council hereby appoints Judge Dick Hoskins Gregg, III and Judge Richard Cope as the associate judges of the Municipal Court of Record in the City of League City for a two-year term beginning February 1, 2026 and ending January 31, 2028 and appointing Judge Shari Goldsberry as associate judges for the Municipal Court of Record in the City of League City for a two-year term beginning January 1, 2026 and ending December 31, 2027.

<u>Section 2</u>. The City approves and authorizes agreements with Dick Gregg, III, (attached as Exhibit A-1), Richard Cope (attached as Exhibit A-2) and Shari Goldsberry (attached as Exhibit A-3) for judicial services at a rate of \$200 per hour and the City Manager is authorized to execute any document necessary to complete this transaction.

<u>Section 3</u>. All ordinances and resolutions or any part thereof in conflict herewith are hereby repealed to the extent of the conflict only.

<u>Section 4</u>. It is hereby found and determined that the meeting at which this ordinance was passed was open to the public and that advance public notice of the time, place and purpose of said meeting was given as required by law.

<u>Section 5.</u> This Ordinance shall be in effect from and after its final adoption.
