Consider and take action on a resolution authorizing a three-year agreement with The Goodyear Tire & Rubber Company (\$180,000) and Southern Tire Mart, LLC (\$204,000) for tire purchases in an amount not to exceed \$384,000 (Director of Public Works)

#### ..Background:

Approval of this resolution will authorize the award of Invitation to Bid (ITB) #24-012 Automotive, Truck and Equipment Tires to The Good Year Tire & Rubber Company (\$180,000) and Southern Tire Mart, LLC (\$204,000) from March 1, 2024 through February 28, 2027 in an amount not to exceed \$384,000 with two (2) additional one-year renewal options available.

On December 27, 2023 the City released ITB #24-012 Automotive, Truck and Equipment Tires for this item. Two (2) sealed bids were received on January 30, 2024, from The Goodyear Tire & Rubber Company and Southern Tire Mart, LLC. Bid tabulation is as follows:

The Goodyear Tire & Rubber Company and Southern Tire Mart, LLC are the City's current vendors for tire purchases. Goodyear brand tires are used for police patrol vehicles, fire apparatus and some of the heavy off-road fleet equipment. Historical annual expenditures for The Goodyear Tire & Rubber Company are \$60,000. Southern Tire Mart, LLC supplies Firestone tires which are primarily used on general automobiles and trucks and some off-road equipment. Annual expenditures for Southern Tire Mart, LLC are anticipated to be \$68,000 for a total cost of \$128,000 for all tire purchases per fiscal year.

Based on the bid pricing and previous service history, staff recommends awarding ITB# 24-012 Automotive, Truck and Equipment Tires contract to The Goodyear Tire & Rubber Company and Southern Tire Mart, LLC as both vendors have proven they can meet the need of the city's demands for the products requested while offering the best pricing available.
