Background	<p>December 19, 2025 – Notice of the public hearings was published in the paper and posted at City Hall.</p> <p>January 8, 2026 – The Planning and Zoning Commission is scheduled to hold a public hearing and make a recommendation to City Council.</p> <p>January 27, 2026 – City Council is scheduled to hold a public hearing and hear the item on first reading.</p> <p>February 24, 2026 – Subject to approval on first reading, City Council is scheduled to hear the item on second reading.</p> <p>Councilmembers Cones and Higgenbotham co-sponsored the proposed amendments to the Unified Development Code (UDC).</p>
Changes to the Ordinance	The proposed ordinance amendment would allow used car sales with a Special Use Permit in the “CG” (General Commercial) District. The amendment would also establish the following definitions for Used Car Sales in Appendix A of the UDC.
	<p>Used Car Sales means a retail motor vehicle establishment where previously titled, leased, or owned vehicles are offered for sale or trade. Such establishments may include offices, customer service areas, and designated display areas. Minor mechanical services incidental to preparing vehicles for sale are allowed, provided they occur entirely within enclosed bays. This use does not include major automotive repair, towing and storage yards, or salvage operations.</p>

Appendix A – Definitions

USED CAR SALES means a retail motor vehicle establishment where previously titled, leased, or owned vehicles are offered for sale or trade. Such establishments may include offices, customer service areas, and designated display areas. Minor mechanical services incidental to preparing vehicles for sale are allowed, provided they occur entirely within enclosed bays. This use does not include major automotive repair, towing and storage yards, or salvage operations.
