

**INTERLOCAL AGREEMENT FOR BOUNDARY ADJUSTMENT
BETWEEN LEAGUE CITY AND FRIENDSWOOD**

This Interlocal Agreement (the "Agreement") is entered on the date indicated below between the City of League City, Texas (the "League City") and the City of Friendswood ("Friendswood"), collectively known together as the "Parties".

RECITALS

WHEREAS, the Parties intend this Agreement to follow Chapter 791 of the Government Code, cited as the Interlocal Cooperation Act; and

WHEREAS, the Parties are neighboring municipalities that currently share common boundaries; and

WHEREAS, the Avalon Development currently straddles the corporate limits of the Parties, with 59.521 acres being in the corporate limits of Friendswood and 26.921 acres being in the corporate limits of League City; and

WHEREAS, the 26.921 acres tract of land from the Avalon Development (the "Property") in League City which is subject to this Boundary Adjustment Agreement and fully described in **Exhibit "A"** attached hereto and incorporated herein for all purposes, is less than 1,000 feet in width; and

WHEREAS, Texas Local Government Code Section 43.015 authorizes adjacent municipalities to make mutually agreeable changes in their boundaries of areas that are less than 1,000 feet in width; and

WHEREAS, the Parties have determined that it is not feasible for the League City to provide services to the Property given its unique geographical layout; and

WHEREAS, pursuant to Texas, Local Government Code Section 43.015, Friendswood and League City desire to adjust their corporate boundaries lines, whereby League City will release 26.921 acres of land from the Avalon Development, (the "Property"), from its corporate limits to be relinquished to and become a part of the corporate limits of Friendswood and Friendswood will accept this land from League City to become part of the corporate limits of Friendswood;

NOW THEREFORE, for valuable consideration, the receipt and sufficiency of which is acknowledged, the Parties agree to the following terms:

TERMS

1. Incorporation of Recitals. The recitals set forth above are true and correct and are hereby incorporated into this Agreement.
2. Term of Agreement. The effective date of this Agreement shall be on the date of execution by all Parties and shall continue until March 1, 2041.

3. Adoption by Ordinance. It is hereby agreed that the respective governing bodies of Friendswood and League City shall adopt by Ordinance this Agreement and its Exhibits on or before May 15, 2021, making mutually agreeable changes in their corporate boundaries, in which League City shall release 26.921 acres of land from the Avalon Development, (the "Property"), from its corporate limits to be relinquished to and become a part of the corporate limits of Friendswood and Friendswood will accept this land from League City to become part of the corporate limits of Friendswood who will provide the required municipal services.
4. Changes in Boundaries. Pursuant to Texas Local Government Code Sections 43.003 and 43.015, Friendswood and League City hereby agree that the boundaries between the cities will be adjusted as depicted in Exhibit "B", which is attached hereto and incorporated herein for all purposes. The Parties agree to protect, preserve and defend the mutually agreeable changes in their boundaries as depicted above.
5. Official Map. The respective governing bodies of Friendswood and League City shall take appropriate action to effectuate the terms of this Boundary Agreement through the adoption of an official map ("Official Map") showing their respective boundaries as required by Texas Local Government Code Section 41.001.
6. Notice of Official Boundary Change. The Parties shall send to the clerk of each county in which the municipality is located a certified copy of this Agreement and Exhibits with the Ordinance adopting and authorizing the execution of this Agreement, and Parties shall file these documents in the deed records of Galveston and Harris Counties within thirty (30) days of adoption
7. Payment by Friendswood. The Parties agree that Friendswood shall pay to League City on or before March 1 of each year, an annual amount equal to fifty percent (50%) of the property taxes generated from the Property, with the first payment being due on or before March 1, 2022, and the final payment being due on or March 1, 2041.
8. Assignment. No assignment of this Agreement, in whole or in part, for any purpose shall be made by either party without the written consent of the other party. Subject to this limitation, this Agreement shall bind and inure to the benefit of the successors and assigns of the Parties.
9. Interpretation of Agreement. This Agreement or any portion thereof shall not be interpreted by a court of law to the detriment of a party based solely upon that party's authorship of the Agreement or any portion thereof.
10. Severability. If for any reason, any one or more paragraphs of this Agreement are held legally invalid, such judgment shall not prejudice, affect, impair or invalidate the remaining paragraphs of this Agreement as a whole.
11. Entire Agreement. This Agreement constitutes the entire Agreement between the parties hereto and supersedes all prior agreements, understandings and arrangements, oral or written, between the parties thereto with respect to the subject thereof.
12. Governing Law and Venue. This Agreement shall be construed and enforced in accordance with and governed by the laws of the State of Texas and the venue for any cause of action shall be brought in

Galveston County, Texas.

13. Execution in Counterparts. This Agreement may be executed in any number of counterparts, each of which shall be deemed to be an original and all of which together shall be deemed to one and the same instrument.
14. No Joint Venture. This Agreement is not intended to create, nor should it be construed as creating a partnership, association, joint venture, or trust.
15. No Waivers. The waiver by any party hereto of a breach of any term or provision of this Agreement shall not be construed as a waiver of any subsequent breach.
16. Current Revenues Available. All parties agree that any payments that are made under this Agreement for government functions or services will be made from current revenues available to the paying party.
17. No Third-Party Beneficiary. Nothing in this Agreement shall entitle any third party to any claim, cause of action, remedy or right of any kind, it being the intent of the parties that this Agreement shall not be construed as a third-party beneficiary contract.
18. Force Majeure. If by reason of Force Majeure, the City shall be unable in whole or in part to carry out its obligations under this Agreement in accordance with the terms and conditions of this Agreement, it shall not be considered a breach by this Agreement. The term "Force Majeure" as used in this Agreement shall mean acts of God, strikes, lock-outs, or other industrial disturbances, acts of public enemy, orders of any kind of the federal or state government, or any civil or military authority, insurrection, riots, epidemics, landslides, lighting, earthquakes, fires, hurricanes, storms, floods, washouts, droughts, arrests, restraint of government and people, civil disturbances, explosions, breakage or accidents to machinery, pipelines or canals, the partial or entire failure of the City, or any other causes not reasonably within the control of the City.
19. Immunity. It is expressly understood and agreed that, in the execution of this Agreement, the Parties do not waive any immunity or defense that would otherwise be available to it against claims arising in the exercise of governmental powers and functions.
20. Authority to Bind.
 - a. Each Party represents and warrants for itself that this Agreement, in accordance with the requirements of the Interlocal Cooperation Act and that it has been authorized by its' respective governing body.
 - b. Each Party represents and warrants for itself that the individual executing this Agreement on its behalf has the full power and authority to do so and to legally bind the Party to all the terms and provisions of this Agreement and that this Agreement constitutes the legal, valid, and binding agreement of each Party hereto.

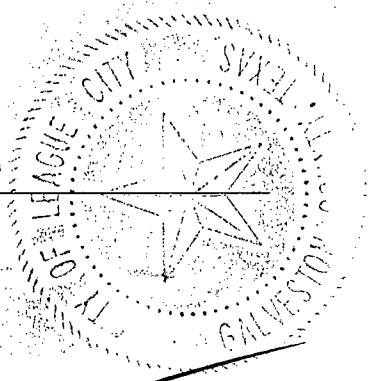

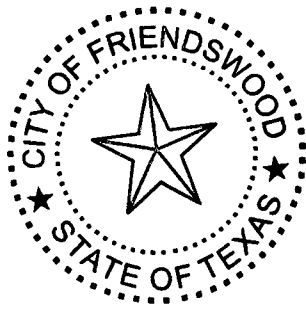

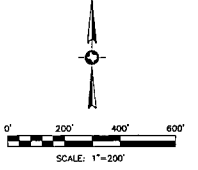

Map showing mutually agreeable changes in City boundaries

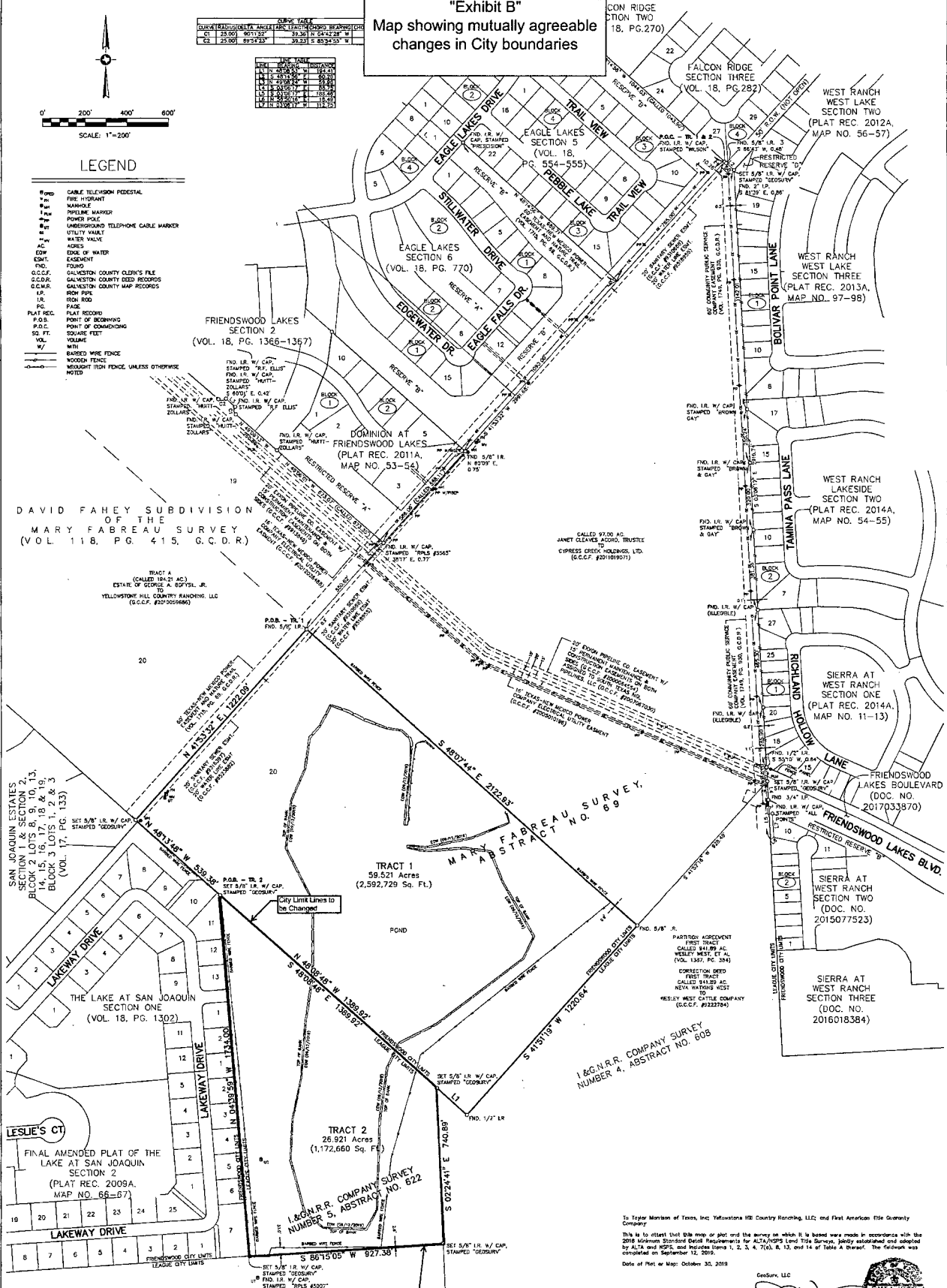

ORDINANCE NO. 2021-12

AN ORDINANCE APPROVING AN INTERLOCAL AGREEMENT ADJUSTING THE CORPORATE BOUNDARY LINES BETWEEN THE CITY OF FRIENDSWOOD, TEXAS, AND THE CITY OF LEAGUE CITY, TEXAS, INCLUDING 26.921 ACRES FROM THE AVALON DEVELOPMENT; AUTHORIZING THE CITY MANAGER TO EXECUTE THE AGREEMENT AND THE CITY SECRETARY TO ATTEST; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Avalon development currently straddles the corporate limits of the City of Friendswood and the City of League, with approximately 59.521 acres being in the corporate limits of the City of Friendswood, Texas and approximately 26.921 acres within the corporate limits of the City of League City; and

WHEREAS, the 26.921 acre tract located in the corporate limits of the City of League City is less than 1,000 feet in width, and pursuant to Texas Local Government Code Section 43.015, adjacent municipalities may make mutually agreeable changes in their boundaries of areas that are less than 1,000 feet in width; and

WHEREAS, the City of Friendswood, Texas seeks to enter into an interlocal agreement with the City of League City, Texas in order to adjust their respective corporate boundaries, whereby League City will release 26.921 acres of land from the Avalon Development, (the "Property"), from its corporate limits to be relinquished to and become a part of the corporate limits of Friendswood and Friendswood will accept this land from League City to become part of the corporate limits of Friendswood; and

WHEREAS, the City Council of the City of Friendswood, Texas, finds and determines that the exchange of boundaries is in the best interest of the health, safety, morals and welfare of the citizens of the City of Friendswood, and does, by this ordinance, approve such interlocal agreement, a true and correct copy of which is attached hereto and incorporated as Exhibit "A."

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FRIENDSWOOD,
STATE OF TEXAS:**

Section 1. That the City Manager and City Secretary are hereby authorized and directed to execute and attest, respectively, the Boundary Agreement by and between the City of Friendswood, Texas, and the City of League City, Texas, a true and correct copy of which is attached hereto and incorporated as Exhibit "A."

Section 2. That the City Secretary is hereby directed to effectuate an amendment of the City's Official Map to incorporate the changes effected by the Boundary Agreement and to file copies thereof, along with a certified copy of this Ordinance, Agreement and Exhibits, with the County Clerks of Galveston and Harris Counties, Texas.

Section 3. That this ordinance shall become effective upon its passage and approval.

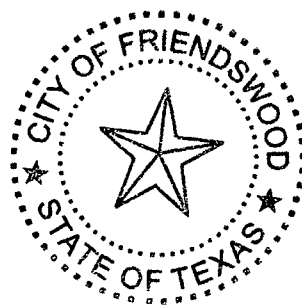

WHEREAS, the 26 921 acres tract of land from the Avalon Development (the "Property") in League City which is subject to this Boundary Adjustment Agreement and fully described in **Exhibit "A"** attached hereto and incorporated herein for all purposes, is less than 1,000 feet in width, and

WHEREAS, Texas Local Government Code Section 43 015 authorizes adjacent municipalities to make mutually agreeable changes in their boundaries of areas that are less than 1,000 feet in width, and

WHEREAS, the Parties have determined that it is not feasible for the League City to provide services to the Property given its unique geographical layout; and

WHEREAS, pursuant to Texas, Local Government Code Section 43 015, Friendswood and League City desire to adjust their corporate boundaries lines, whereby League City will release 26 921 acres of land from the Avalon Development, (the "Property"), from its corporate limits to be relinquished to and become a part of the corporate limits of Friendswood and Friendswood will accept this land from League City to become part of the corporate limits of Friendswood,

NOW THEREFORE, for valuable consideration, the receipt and sufficiency of which is acknowledged, the Parties agree to the following terms

TERMS

- 1 Incorporation of Recitals The recitals set forth above are true and correct and are hereby incorporated into this Agreement.
- 2 Term of Agreement The effective date of this Agreement shall be on the date of execution by all Parties and shall continue until March 1, 2041

- 3 Adoption by Ordinance. It is hereby agreed that the respective governing bodies of Friendswood and League City shall adopt by Ordinance this Agreement and its Exhibits on or before May 15, 2021, making mutually agreeable changes in their corporate boundaries, in which League City shall release 26 921 acres of land from the Avalon Development, (the "Property"), from its corporate limits to be relinquished to and become a part of the corporate limits of Friendswood and Friendswood will accept this land from League City to become part of the corporate limits of Friendswood who will provide the required municipal services
- 4 Changes in Boundaries. Pursuant to Texas Local Government Code Sections 43 003 and 43 015, Friendswood and League City hereby agree that the boundaries between the cities will be adjusted as depicted in Exhibit "B", which is attached hereto and incorporated herein for all purposes. The Parties agree to protect, preserve and defend the mutually agreeable changes in their boundaries as depicted above
- 5 Official Map. The respective governing bodies of Friendswood and League City shall take appropriate action to effectuate the terms of this Boundary Agreement through the adoption of an official map ("Official Map") showing their respective boundaries as required by Texas Local Government Code Section 41 001
- 6 Notice of Official Boundary Change. The Parties shall send to the clerk of each county in which the municipality is located a certified copy of this Agreement and Exhibits with the Ordinance adopting and authorizing the execution of this Agreement, and Parties shall file these documents in the deed records of Galveston and Harris Counties within thirty (30) days of adoption
- 7 Payment by Friendswood. The Parties agree that Friendswood shall pay to League City on or before March 1 of each year, an annual amount equal to fifty percent (50%) of the property taxes generated from the Property, with the first payment being due on or before March 1, 2022, and the final payment being due on or March 1, 2041
- 8 Assignment. No assignment of this Agreement, in whole or in part, for any purpose shall be made by either party without the written consent of the other party. Subject to this limitation, this Agreement shall bind and inure to the benefit of the successors and assigns of the Parties
- 9 Interpretation of Agreement. This Agreement or any portion thereof shall not be interpreted by a court of law to the detriment of a party based solely upon that party's authorship of the Agreement or any portion thereof
- 10 Severability. If for any reason, any one or more paragraphs of this Agreement are held legally invalid, such judgment shall not prejudice, affect, impair or invalidate the remaining paragraphs of this Agreement as a whole
- 11 Entire Agreement. This Agreement constitutes the entire Agreement between the parties hereto and supersedes all prior agreements, understandings and arrangements, oral or written, between the parties thereto with respect to the subject thereof
- 12 Governing Law and Venue. This Agreement shall be construed and enforced in accordance with and governed by the laws of the State of Texas and the venue for any cause of action shall be brought in

Galveston County, Texas

- 13 Execution in Counterparts This Agreement may be executed in any number of counterparts, each of which shall be deemed to be an original and all of which together shall be deemed to one and the same instrument.
- 14 No Joint Venture This Agreement is not intended to create, nor should it be construed as creating a partnership, association, joint venture, or trust.
- 15 No Waivers The waiver by any party hereto of a breach of any term or provision of this Agreement shall not be construed as a waiver of any subsequent breach
- 16 Current Revenues Available All parties agree that any payments that are made under this Agreement for government functions or services will be made from current revenues available to the paying party
- 17 No Third-Party Beneficiary Nothing in this Agreement shall entitle any third party to any claim, cause of action, remedy or right of any kind, it being the intent of the parties that this Agreement shall not be construed as a third-party beneficiary contract.
- 18 Force Majeure If by reason of Force Majeure, the City shall be unable in whole or in part to carry out its obligations under this Agreement in accordance with the terms and conditions of this Agreement, it shall not be considered a breach by this Agreement. The term "Force Majeure" as used in this Agreement shall mean acts of God, strikes, lock-outs, or other industrial disturbances, acts of public enemy, orders of any kind of the federal or state government, or any civil or military authority, insurrection, riots, epidemics, landslides, lighting, earthquakes, fires, hurricanes, storms, floods, washouts, droughts, arrests, restraint of government and people, civil disturbances, explosions, breakage or accidents to machinery, pipelines or canals, the partial or entire failure of the City, or any other causes not reasonably within the control of the City
- 19 Immunity It is expressly understood and agreed that, in the execution of this Agreement, the Parties do not waive any immunity or defense that would otherwise be available to it against claims arising in the exercise of governmental powers and functions
- 20 Authority to Bind
 - a Each Party represents and warrants for itself that this Agreement, in accordance with the requirements of the Interlocal Cooperation Act and that it has been authorized by its' respective governing body
 - b Each Party represents and warrants for itself that the individual executing this Agreement on its behalf has the full power and authority to do so and to legally bind the Party to all the terms and provisions of this Agreement and that this Agreement constitutes the legal, valid, and binding agreement of each Party hereto



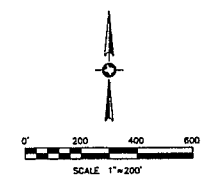

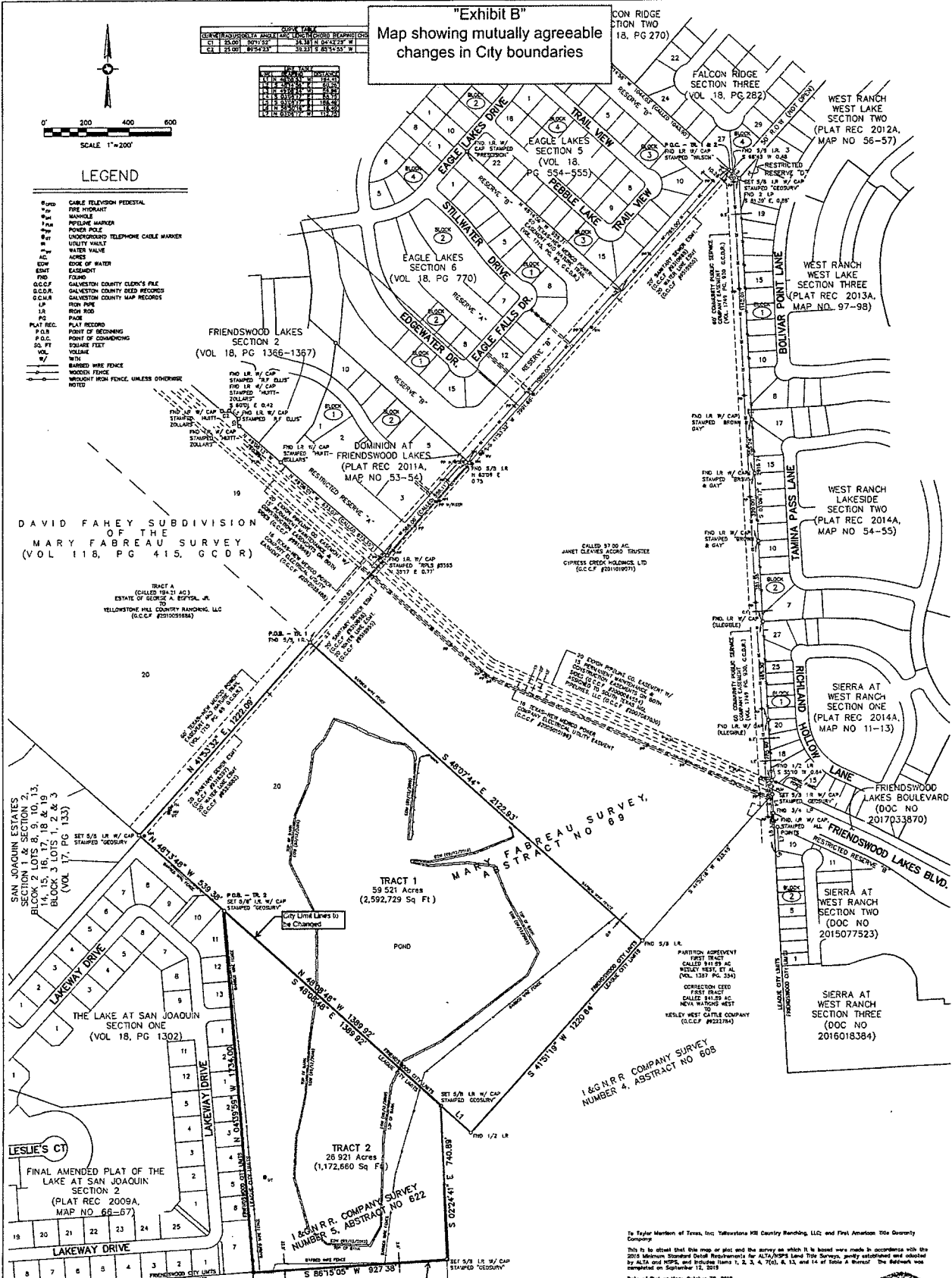

ORDINANCE NO. 2021-12

AN ORDINANCE AUTHORIZING A BOUNDARY ADJUSTMENT AGREEMENT WITH THE CITY OF FRIENDSWOOD SO THAT 26.921 ACRES OF LAND, WHICH IS LOCATED IN LEAGUE CITY, TEXAS AND HAS A WIDTH OF LESS THAN 1,000 FEET, WILL BE LOCATED IN THE CITY LIMITS OF FRIENDSWOOD; FINDING THAT ALL NECESSARY AND REQUIRED LEGAL CONDITIONS HAVE BEEN SATISFIED; PROVIDING THAT SUCH AREA AS DESCRIBED IN EXHIBIT "A" OF SAID BOUNDARY AGREEMENT SHALL BE INCORPORATED INTO THE CITY OF FRIENDSWOOD FOR INCLUSION WITHIN ITS CORPORATE LIMITS; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the City of League City ("League City") and the City of Friendswood ("Friendswood") desire to enter into a Boundary Adjustment Agreement to make mutually agreeable changes in their boundaries; and

WHEREAS, pursuant to Section 43.015 of the Texas Local Government Code adjacent municipalities may make mutually agreeable changes in their boundaries of areas that are less than 1,000 feet in width; and

WHEREAS, the Avalon Development is a new residential development that is mainly located in Friendswood with a small portion (26.921 acres) of the development located in League City and the 26.921 acres of territory in League City is less than 1,000 feet in width; and

WHEREAS, Friendswood has requested that League City release 26.921 acres of its territory, as further described in Exhibit "A" which is incorporated herein, so that the entire the Avalon Development will be located within Friendswood and have Friendswood utilities; and

WHEREAS, Friendswood as agreed to make an annual payment to League City in an amount equal to 50% of the property taxes generated from the released territory over the next twenty (20) years; and

WHEREAS, it would be infeasible for the City to provide utilities to the area in question given the location of certain detention ponds in the development; and

WHEREAS, all necessary and required legal conditions have been satisfied for this boundary adjustment.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LEAGUE CITY, TEXAS, as follows:

Section 1. Incorporation of Recitals. That all the above recitals are found to be true and correct and are incorporated into the body of this ordinance as if fully set forth herein.

Section 2. Boundary Adjustment Agreement. That the Boundary Adjustment Agreement between the City of League City and the City of Friendswood, a true copy of which is attached hereto as Exhibit "A" and made a part hereof for all purposes, is hereby authorized and the City Manager is authorized to execute all documents necessary to complete this transaction.

Section 3. Relinquishment of Tract 2. Upon the full execution of the Boundary Adjustment Agreement, the City of League City does hereby relinquish that certain tract of land currently situated within League City and described in Exhibit "A" – Tract 2, to be within the corporate limits of Friendswood.

Section 4. Official Map. The official maps and boundaries of League City, heretofore adopted and amended, shall be and is hereby amended to reflect the boundary adjustments described in Exhibit "A".

Section 5. Copy to County Clerk. The City Secretary is hereby directed to send a certified copy of this ordinance to the Office of the County Clerks of Harris and Galveston Counties.

Section 6. Savings. All rights and remedies which have accrued in favor of the City under this Ordinance and amendments thereto shall be and are preserved for the benefit of the City.

Section 7. Severability. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid, unconstitutional or otherwise unenforceable by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions thereof.


Section 8. Repealer. All ordinances and parts of ordinances in conflict herewith are hereby repealed but only to the extent of such conflict.

Section 9. Publication and Effective Date. The City Secretary shall cause this Ordinance, or its caption, to be published in the official newspaper of the City of League City, upon passage of such Ordinance. This Ordinance shall become effective on passage.




