

RESOLUTION NO. 2026-

A RESOLUTION APPROVING A SHORTLIST OF QUALIFIED CONSULTANTS FOR MULTIPLE PROFESSIONAL SERVICE DISCIPLINES PURSUANT TO RFQ NO. 25-040; AUTHORIZING THE USE OF THE SHORTLIST FOR CAPITAL IMPROVEMENT PROGRAM AND RELATED PROFESSIONAL SERVICES THROUGH FISCAL YEAR 2029; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Chapter 2254, Texas Government Code, known as the Professional Services Procurement Act, requires municipalities to select certain professional service providers based on demonstrated competence and qualifications and to negotiate fair and reasonable compensation after selection; and

WHEREAS, in furtherance of and in compliance with Chapter 2254, Texas Government Code, the City of League City, Texas (the "City") issued Request for Qualifications No. 25-040 ("RFQ 25-040") to identify and prequalify consulting firms capable of providing professional services in multiple disciplines in support of the City's Capital Improvement Program ("CIP") and other related municipal projects over a multi-year period; and

WHEREAS, RFQ 25-040 solicited Statements of Qualifications ("SOQs") by individual service discipline, and the SOQs received were evaluated by a multi-departmental committee using established, objective criteria designed to assess qualifications, experience, available resources, project approach, quality control, and references; and

WHEREAS, the shortlist is intended as a flexible procurement tool, does not guarantee the award of work, and does not preclude the City from issuing project-specific requests for qualifications or otherwise procuring professional services in accordance with applicable law, with individual contracts subject to separate City Council authorization; and

WHEREAS, approval of the proposed shortlist supports the City's Strategic Planning Critical Success Factors, including developing and maintaining infrastructure and ensuring long-term financial sustainability, by promoting an efficient, transparent, and legally compliant professional services procurement process.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LEAGUE CITY, TEXAS, as follows:

Section 1. The City hereby approves the shortlist of qualified consultants for multiple professional service disciplines pursuant to RFQ #25 040, which is attached and incorporated at a as Exhibit A.

Section 2. The City Manager or his designee is authorized to execute all documents necessary to complete this transaction.

Section 3. All resolutions and agreements and parts of resolutions and agreements in conflict herewith are hereby repealed to the extent of the conflict only.

Section 4. It is hereby found and determined that the meeting at which this resolution was passed was open to the public and that advance public notice of the time, place and purpose of said meeting was given as required by law.
