ORDINANCE NO. 2025-24

AN ORDINANCE REZONING APPROXIMATELY 1.82 ACRES, (MAP-25-0004) FROM "PS" (PUBLIC/SEMI-PUBLIC) TO "RSF-7" (RESIDENTIAL SINGLE-FAMILY 7), LEGALLY DESCRIBED AS A PORTION OF LOT 20 (20-11) OF THE DIVISION "C" OF THE LEAGUE CITY TOWNSITE, GENERALLY LOCATED WEST OF S. EGRET BAY (FM 270), EAST OF TEXAS AVE., AND APPROXIMATELY 800' TO THE NORTH OF WEBSTER ST. IN THE 300 BLOCK OF ELLEN AVE.

WHEREAS, at the May 1, 1999 General Election the qualified voters of the City of League City voted that staff proceed with the concept of zoning for the City; and

WHEREAS, on August 10, 1999, the City Council of the City of League City, Texas (the "Council") adopted Ordinance No. 99-52 amending the Code of Ordinances of the City of League City to add Chapter 125 regarding zoning; and

WHEREAS, on August 30, 2005, the City Council adopted Ordinance No. 2005-24 amending Chapter 125 of the Code of Ordinances of the City of League City and adopting zoning ordinances and map consistent with the Comprehensive Plan for the City of League City, Texas; and

WHEREAS, on September 29, 2020, the City Council adopted Ordinance No. 2020-25 replacing Chapter 125 "Zoning" with the Unified Development Code (the "UDC"); and

WHEREAS, the City Council considered the recommendation of the Planning and Zoning Commission and duly conducted a public hearing as required by law; and

WHEREAS, the City Council deems it necessary and in the best interest of the citizens to rezone approximately 1.82 acres, (MAP-25-0004) from "PS" (Public/Semi-public) to "RSF-7" (Residential Single-Family 7), legally described as a portion of Lot 20 (20-11) of the Division "C" of the League City Townsite, in the City of League City, Texas as shown in the attached Zoning Map in Exhibit "A" and the property survey in Exhibit "B".

NOW, THEREFORE, BE IT ORDERED BY THE CITY COUNCIL OF THE CITY OF LEAGUE CITY, TEXAS, that:

Section 1. The facts and opinions in the preamble of this ordinance are true and correct.

Section 2. The approximate 1.82 acres, legally described as a portion of Lot 20 (20-11) of the Division "C" of the League City Townsite, in the City of League City, Texas, generally located west of S. Egret Bay (FM 270), east of Texas Ave., and approximately 800' to the north of Webster St. in the 300 block of Ellen Ave as shown in the attached Zoning Map in Exhibit "A"; and the attached property survey in Exhibit "B", shall heretofore be zoned "RSF-7" (Residential Single-Family 7).

<u>Section 3</u>. All ordinances and agreements and parts of ordinances and agreements in conflict herewith are hereby repealed to the extent of the conflict only.
