PROJECT DESCRIPTION

This project renovates the existing FM 270 Public Boat Ramp to accommodate all forms of boats and watercraft. The renovation will remove silt from the launch area and reinforce the bulkhead which is at the end of its useful life.

FY2024-2025

Design - Complete

Reimbursement for design is available through US Fish and Wildlife Service (USFWS) and will reimburse funding allocated to planning and design up to (\$147,750); which will then be used towards construction.

FY2025-2026 Construction \$1.9 million

The City has been approved for a grant through the Texas Parks & Wildlife Department in the amount of \$500,000. The City's match is \$1,438,272 and will be paid from Park Dedication Fees. The City is currently awaiting approval of Environmental Clearance and grant funding to proceed with construction.

PROJECT JUSTIFICATION

This project is necessary primarily for safety reasons. The boat ramp is beginning to deteriorate and will not be usable if not renovated. The renovation will also allow for all types of boats and watercraft to make use of the facility.
